We Advise:

We provide specialist advice to organisations anywhere in the world. We support the development of safeguarding and whistleblowing strategies and good governance. We provide strategic input and representation to advisory panels, working groups, and collaborations between organisations.

We Empower:

We support safeguarding professionals so it's easier for them to do a difficult job. We believe that the safeguarding profession should be better recognised. We recognise the challenge for employers in providing professional development and support to safeguarding professionals.

We Investigate:

We support, supervise, and independently oversee internal investigations; or conduct independent survivor-centred investigations on an organisation's behalf. From single concerns to large scale complex cases, we provide the clarity to organisations so they can make defensible decisions.

The Alert Programme

Responding effectively to safeguarding allegation or concern relating to one of your employees, volunteers or representatives can be challenging for organisations. Those in key decision-making roles can find themselves with conflicts of interest and confidentiality sometimes precludes them relying on others in your organisation. Senior leaders can feel alone, out of their depth, and balancing competing priorities.

The Alert Programme provides your organisation with access to critical safeguarding incident support and the technical advice you need to keep people safe. Our support ensures that you can access one of our team of Strategic Advisors when you need them, at short notice.

We will work with you to assess allegations and concerns, develop a response strategy, addressing immediate and longer-term safeguarding risks, assist with regulatory engagement, and help manage reputational risks. If required, we will assist you in making a referral to an appropriate law enforcement or other statutory agency. We will also provide briefings that can be shared with your governing body and attend internal incident management team meetings, to ensure that incidents are appropriately managed, and that specialist advice is available when it is needed.

Alert Programme membership includes:

- An initial assessment of your organisation's safeguarding profile, leading to a bespoke price and support package. Any issues that might hamper an effective safeguarding response, will be included in a development plan.
- The development of an action plan, in partnership with your team, assuring your organisation's response and ensuring you are well prepared.

What is a Critical Safeguarding Incident?

A Critical Safeguarding Incident as an allegation or concern relating to the conduct of one of your employees or volunteers, that indicates that they may have harmed a child or vulnerable person, placed a child or vulnerable person at risk of harm, or may be unsuitable to work with children or vulnerable people. The concern might relate to the abuse of a child, colleague or adult at risk, sexual harassment, or domestic abuse. Whistleblowing reports relating to safeguarding are within the scope of the Alert Programme.

How much does the Alert Programme costs?

The cost of participating in the Alert Programme can vary because of the safeguarding profile of your organisation. The overwhelming majority of organisations will find their membership of the programme to cost no more than £1,000 per month or an annual fee of £10,000.


Our values
