Dr Joe Sullivan Forensic Psychologist

Dr Sullivan is a Registered Forensic Psychologist, holding a PhD in Forensic Psychology, a master's degree in criminology, a Diploma in Psychology, a degree in applied Social Sciences, and a Certificate of Qualification in Social Work.

Dr Sullivan is an honorary lecturer in Forensic Psychology at the University of Birmingham, UK.

Dr Sullivan has worked with police officers, social workers, probation officers, faith groups and educationalists to provide insights into the motivations, thoughts, and behaviours of child sex offenders.

Dr Sullivan undertakes assessments for Social Services, Probation, Churches, and Education bodies and is an expert witness in the criminal, civil and family courts.

Dr Sullivan has worked extensively in law enforcement, assisting police forces with

investigations into the sexually motivated abduction, murder, and assault of children.

Dr Sullivan was the Chief Forensic Psychologist in the Behaviour Analysis Unit at the Child Exploitation and Online Protection Centre (CEOP), receiving a Chief Constable's Commendation for his work on the investigation of the sexually motivated abduction and murder of a child in 2001.

Dr Sullivan has undertaken assessment and therapeutic intervention work with women who sexually abuse children and adults accused or suspected of professional sexual misconduct. Part of his work also includes the assessment and treatment of adult survivors of child sexual abuse.

Dr Sullivan has published and presented papers to national and international conferences on the techniques he uses for engaging, assessing, and interviewing sexual offenders.



Understanding Sex Offenders: Foundation Course in Behavioural Analysis

Introduction:

This two-day course explores the psychology of child sex offenders and provides participants with a practical framework for recognising and correctly interpreting offender behaviour. Key learning points arm professionals to engage more effectively with offenders and/or to safeguard children in their care.

This course forms an important foundation of understanding for frontline practitioners in policing, social care, safeguarding investigators, and those responsible for organisational safeguarding of children. Feedback has shown us that those who work with victims and their families have also benefitted hugely from this training.

Interviewing Sex Offenders

Introduction:

This three-day course provides participants with a tried and tested methodology for developing, preparing, and implementing effective interview strategies with perpetrators of child sexual abuse and those about whom there are concerns, both in the online and offline environments.

This training ensures that all participants will recognise the value of crucial information and teaches how to harness it to further develop the interview. By analysing a series of video interviews with offenders, participants get a first-hand opportunity to understand how interview skills can be implemented and built upon.

Dr Sullivan's comprehensive specialist interview system has been specifically designed to enhance the skills and knowledge of those professionals who interview child sex offenders during law enforcement investigations, child protection evaluations and risk assessment and/or management of offenders.

This course provides core knowledge and skills for those whose work involves interviewing or meeting with sex offenders. It is particularly relevant to offender managers, social workers, and public protection officers. The content is beneficial to those engaged in risk assessments, intervention programmes, investigation and/or risk management.

'Just looking?': Evaluating Risk in Online Behaviour

Introduction:

This course explains how some individuals use technology, enabling us to develop more informed risk assessment and law enforcement strategies and to provide more effective safeguarding.

Participants explore key issues, including whether possessing indecent images of children indicates a risk of contact offending and the similarities between online and offline offending. Child sexual exploitation can occur in varying forms and front-line professionals increasingly need to understand how technology can be used.

This course is essential for all those who work with children, have safeguarding responsibility, and want to develop a culture of safety in their organization. It provides core knowledge and skills for those who work either directly or indirectly with offenders and their families.

It is relevant to law enforcement as it provides skills for investigative strategies as well as the management of offenders in the community.

Topics covered include:

- Up-to-date research findings about technology-facilitated exploitation of children
- Indecent images and stories understanding their role.
- 3. Collecting and distributing indecent images of children the risk significance
- 4. Producers of indecent images of children who are they?
- 5. Online grooming web cam technology as an exploitative tool

- 6. Convergence the role of mobile phone technology
- 7. How offenders exploit children engaged in risky behaviour
- 8. How women offenders use the internet
- 9. Networking behaviours and organised groups

What participants gain:

By the end of the course, participants will be able to:

- Understand the potential applications of behaviour analysis in working with offenders who use technology to facilitate offending.
- 2. Identify the key issues in 'image-based child sexual exploitation'.
- 3. Use behaviour analysis tools in analysing evidence in child sexual exploitation cases.
- 4. Identify the key risk factors in cases involving indecent images of children.
- 5. Recognise 'chat-based child exploitation' and online grooming behaviours.
- 6. Understand how women use technology and internet to facilitate the sexual exploitation of children.
- Know what questions to ask when working in child exploitation via technology.
- 8. Understand how individuals can use different technologies to exploit children/vulnerable adults.

Whilst the course deals with issues around technology, participants do not need an advanced technological knowledge.



Young People Experiencing & Exhibiting Problematic Sexual Behaviour

Introduction:

This course uses up-to-date research and draws on clinical experience to give professionals new knowledge and skills, empowering them to undertake accurate assessments and to work in complex family situations more effectively.

Any work with a child who has either experienced or perpetrated Problematic Sexual Behaviour (PSB) or who has been involved in both situations ideally involves their primary carers and will most likely include various professionals in different capacities in the young person's life.

This course underpins the relevance of such an approach and explains why it so important to progress in a holistic way.

The course is designed to enable participants to feel more confident in dealing with the fast-evolving world of child sexual exploitation and in how to work with children who have a complexity of needs relating to Problematic Sexual Behaviour.

This course is essential for all those who work with young people or care for them as well as those who have a safeguarding responsibility and want to develop a culture of safety within their organisation.

This course provides core knowledge and skills for those who work either directly or indirectly with children, offenders, and their families.

The course is relevant to law enforcement as it provides skills relevant to investigative strategies as well as involvement with young people with complex histories.

Topics covered include:

- 1. Vulnerability factors for children
- 2. Why children don't tell; why children retract allegations.
- 3. Multi-faceted grooming of children: the implications for families and professionals
- 4. Technology, children, and problematic sexual behaviour
- 5. Compliant and complicit victims what the terms really mean.
- 6. Understanding children who engage in PSB.
- 7. Caring for children who have experienced sexual abuse.
- 8. Issues for risk management with children exhibiting PSB.
- 9. Assessment and intervention for children engaging in PSB.
- 10. Recidivism in children who engage in problematic sexual behaviour.

What participants gain:

By the end of the course, participants will be able to:

- 1. Understand the factors contributing to the specific impact of abuse on victims.
- 2. Identify vulnerability factors in children with whom they come into contact.
- 3. Engage more effectively with families and young people.
- 4. Evaluate the risks associated with modern technologies and young people, its uses, and abuses.
- 5. Inform decision-making with up-to-date research and knowledge.
- 6. Better understand the motivations and risk factors in young people who engage in PSB.
- 7. Implement balanced risk management strategies.
