TO ESTABLISH THE DIVINE RIGHTS AND DOMINION ACT

Pursuant to the Moorish National Republic of Peace Constitution (2025), Amendment XVIII, Section 3, wherein it states:

"The Moorish National Republic of Peace shall make all Laws which shall be necessary and proper for carrying out the powers vested in its government, departments, and officers under this Constitution," there shall hereby be designated The Divine Rights and Dominion Act provisions to serve this purpose.

This Public Law shall go into immediate force.

ARTICLE I - GENERAL PROVISIONS

Section 1. Purpose

The **Divine Rights and Dominion Act** is established to affirm the inherent dominion of the **Moorish Nationals** over land, resources, and governance as a divine right granted by the Creator. It recognizes the sovereignty of the **Moorish National Republic of Peace** and ensures the unalienable rights of its People to self-governance, land stewardship, and spiritual preservation.

Section 2. Definitions

1. **Dominion** – The authority and responsibility to govern and utilize natural resources for the collective benefit of the Moorish Nationals.
2. **Natural Resources** – Includes land, water, air, minerals, flora, fauna, and other elements essential for sustaining life and governance.
3. **Sacred Duty** – The spiritual and legal obligation to protect and preserve the natural resources entrusted to the People by the Creator.
4. **Religious Freedom** – The right to practice, govern, and express one's spiritual beliefs without external interference.

Section 3. Recognition of Divine Authority

The **Moorish National Republic of Peace** acknowledges that its **Nationals** are vested with divine authority over their land, governance, and destiny. This Act enshrines that authority as an integral aspect of the **Moorish National Republic of Peace Constitution** and mandates that all **Nationals** exercise their dominion in accordance with divine law and national sovereignty.

ARTICLE II - DIVINE RIGHT TO DOMINION

Section 4. Right to Resources

(a) The Moorish Nationals are entitled to access and utilize all natural resources necessary for sustaining life, establishing self-governance, and achieving spiritual fulfillment. This includes:

- Land for habitation and agriculture
- Water for sustenance and purification
- Airspace and atmospheric resources
- Mineral wealth and energy reserves
- Economic trade and commercial assets

(b) No external entity, foreign government, or private corporation shall usurp or claim ownership over resources that rightfully belong to the **Moorish National Republic of Peace and its Nationals**.

Section 5. Sacred Duty of Stewardship

All **Nationals** of the **Moorish National Republic of Peace** shall uphold their sacred duty to preserve, protect, and maintain their land and resources in accordance with divine law. This stewardship includes:

1. **Sustainable use of land and water** to prevent depletion and destruction.
2. **Protection of indigenous flora and fauna** to maintain ecological balance.
3. **Development of self-sustaining agricultural and economic systems** to ensure prosperity.
4. **Preservation of cultural and spiritual sites** as part of the Nation's divine heritage.

ARTICLE III - RELIGIOUS FREEDOM AND LEGAL PROTECTION

Section 6. Inviolability of Religious Rights

- (a) The right of **Moorish Nationals** to practice, express, and govern in accordance with their divine beliefs is absolute and shall not be infringed upon by any external authority.
- (b) Any attempt by foreign entities to interfere with the religious governance, property, or legal standing of the **Moorish National Republic of Peace** shall be deemed an act of aggression.

Section 7. Legal Framework for Enforcement

- (a) The **Moorish National Republic of Peace Supreme Council** shall oversee the enforcement of all rights and protections outlined in this Act.
- (b) All disputes regarding dominion, resource allocation, or violations of this Act shall be adjudicated solely by the judicial system of the **Moorish National Republic of Peace**.
- (c) Any violation of this Act shall be met with appropriate legal and diplomatic measures, including but not limited to:
- Financial reparations
 - Land reclamation
 - Trade restrictions
 - International litigation

ARTICLE IV - INTERNATIONAL RECOGNITION

Section 8. Affirmation of Sovereign Status

The **Moorish National Republic of Peace** affirms its sovereign status in accordance with:

- **The Montevideo Convention on the Rights and Duties of States (1933)**
- **The United Nations Declaration on the Rights of Indigenous Peoples (2007)**
- **The Universal Declaration of Human Rights (1948)**
- **The American Declaration on the Rights of Indigenous Peoples (2016)**

Section 9. Diplomatic and Trade Relations

The **Moorish National Republic of Peace** retains the right to enter into diplomatic agreements, trade arrangements, and international treaties that align with its national interests. Any agreements must be reviewed and ratified by the **Supreme Council**.

ARTICLE V - IMPLEMENTATION AND FINAL PROVISIONS

Section 10. Oversight and Regulation

(a) A **National Dominion Authority** shall be established to oversee the execution of this Act, ensuring compliance with all provisions.

(b) All land, natural resources, and commercial enterprises operating under this jurisdiction shall be registered with the **National Dominion Authority**.

Section 11. Penalties for Violations

Any entity or individual found in violation of this Act shall be subject to:

- **Fines up to 1,000,000 Noble Dollars**
- **Revocation of trade privileges**
- **Legal prosecution under MNRP jurisdiction**

Section 12. Enactment

This Act shall take effect immediately upon ratification by the **Moorish National Republic of Peace Supreme Council**.
