TO ESTABLISH CHILD RIGHTS PROTECTION ACT

Pursuant to the Moorish National Republic of Peace Constitution (2025), Amendment XVIII, Section 3, wherein it states:

"The Moorish National Republic of Peace shall make all Laws which shall be necessary and proper for carrying out the powers vested in its government, departments, and officers under this Constitution," there shall hereby be designated Child Rights Protection Act provisions to serve this purpose.

This Public Law shall go into immediate effect.

CHILD RIGHTS PROTECTION ACT

The **Moorish National Republic of Peace**, as a sovereign government, acknowledges and upholds the divine and inherent rights of all children. This Act ensures that every child under its jurisdiction is provided protection, care, and the fundamental necessities required for their holistic development in accordance with the principles of **Love, Truth, Peace, Freedom, and Justice**.

SECTION 1. Rights of the Child

- Every child, without any exception whatsoever, shall be entitled to these rights without distinction or discrimination based on race, color, sex, language, religion, national or social origin, property, birth, or other status.

SECTION 2. Protection and Development

- Children shall be provided with all necessary protections and opportunities to develop physically, mentally, morally, spiritually, and socially in a healthy and dignified manner.
- The well-being of children shall be the paramount consideration in all legal, social, and governmental actions affecting them.

SECTION 3. Name and Nationality

- Every child shall be entitled from birth to a name and nationality under the **Moorish National Republic of Peace**.

SECTION 4. Social Security and Welfare

- All children shall have access to adequate nutrition, housing, healthcare, and recreational opportunities.
- Expecting mothers shall receive pre-natal and post-natal care to ensure the health and development of the child.

SECTION 5. Rights of Special Needs Children

- Children with physical, mental, or social disabilities shall receive specialized care, education, and protections tailored to their needs.

SECTION 6. Family and Parental Rights

- The child has the right to be raised in a stable, loving environment within the care and responsibility of their parents.
- The government shall ensure provisions for orphaned and destitute children, including secure placement and guardianship in loving homes.

SECTION 7. Education and Cultural Development

- Every child shall have the right to free and compulsory education.

- Education shall promote moral values, cultural heritage, and the development of responsible, knowledgeable, and conscientious Nationals.
- The right to play and recreation shall be upheld, with community efforts to facilitate these opportunities.

SECTION 8. Protection from Harm

- The child shall be protected from all forms of neglect, abuse, exploitation, and trafficking.
- No child shall be subjected to child labor or any employment that may endanger their health, well-being, or education.

SECTION 9. Protection from Discrimination

- Children shall be raised in an atmosphere of understanding, tolerance, and unity, free from racial, religious, or social discrimination.

SECTION 10. Birthright and Inheritance

- No child shall be deprived of their birthright, inheritance, or rightful nationality under the **Moorish National Republic of Peace**.

SECTION 11. Penalties for Violations

- Any violation of this Act shall be punishable under the **Moorish National Republic of Peace Republic Rules and Civil Procedures**.
- Offenders found guilty of crimes against children may face fines, imprisonment, or capital punishment in cases of severe violations, including trafficking, abuse, and crimes causing severe harm.

SECTION 12. Constitutional Protections

- All children are protected under the **Moorish National Republic of Peace Constitution, Public Laws, and Republic Rules**.

Signed into Law on **March 23, 2025**
