TO ESTABLISH IDENTIFICATION ACT

TO ESTABLISH THE IDENTIFICATION SYSTEM OF THE NATION-STATE

Pursuant to the Moorish National Republic of Peace Constitution (2025), Amendment XVIII, Section 3, wherein it states:

"The Moorish National Republic of Peace shall make all Laws which shall be necessary and proper for carrying out the powers vested in its government, departments, and officers under this Constitution,"

There shall hereby be designated National Identification System provisions to serve this purpose.

This Public Law shall go into immediate effect.

SECTION 1: ISSUANCE OF NATIONAL IDENTIFICATION DOCUMENTS

1. **Official Government-Issued Identification:**

a. The **Moorish National Republic of Peace** shall issue the following forms of identification to Moroccan Nationals and Citizens:

- **Moorish National Republic of Peace National Identification Card**
- **Moorish National Republic of Peace Travel Credentials**
- **Moorish National Republic of Peace Passport**
- **National Elector Identification Card**
- **Moorish National Republic of Peace Business & Commercial Licenses**

2. **Purpose and Use:**

a. These documents shall serve as the official identification of the bearer within the jurisdiction of the **Moorish National Republic of Peace** and shall be recognized as valid forms of identification for lawful purposes, including but not limited to:

- Establishing Nationality and Citizenship within the Moroccan Nation-State
- Engaging in commercial transactions under National and International Law
- Exercising Rights and Protections under the Constitution

3. **Registration and Authentication:**

a. All identification documents issued by the **Moorish National Republic of Peace** shall be authenticated, recorded, and secured within the **National Identification Registry**.

b. Unauthorized reproduction, alteration, or fraudulent use of these documents shall constitute a violation of this Act and be subject to penalties outlined in **Section 6**.

SECTION 2: AUTHORITY TO ISSUE IDENTIFICATION DOCUMENTS

1. **Sovereign Authority Over Identification:**

a. The **Moorish National Republic of Peace Government** shall oversee the issuance of all identification documents exclusively through designated **National Government Agencies**.

b. The **Ministry of Records and Identification** shall regulate and control the issuance, renewal, and security of all identification documents.

2. **Eligibility for National Identification:**

a. Only verified **Moroccan Nationals and Citizens** of the **Moorish National Republic of Peace** may receive identification.

b. Proof of Nationality or Citizenship must be established by lawful declaration and confirmation under the Republic's Constitutional provisions.

SECTION 3: IDENTIFICATION CLASSIFICATIONS

1. **Moorish National Republic of Peace National Identification Card**
 - a. Recognized as the **Primary Government-Issued Identification** for all Moroccan Nationals and Citizens.
 - b. Serves as verification of legal standing within the Nation-State.
 2. **Moorish National Republic of Peace Travel Credentials**
 - a. Issued to Moroccan Nationals for domestic and international travel.
 - b. Contains biometric security measures for authentication.
 3. **Moorish National Republic of Peace Passport**
 - a. Recognized internationally as the official **sovereign passport** of the Nation-State.
 - b. Issued exclusively to Nationals and Citizens for global recognition.
 4. **National Elector Identification Card**
 - a. Required for participation in national and provincial elections.
 - b. Validates eligibility for voting within the Republic's electoral system.
 5. **Business & Commercial Licensing Identification**
 - a. Required for engaging in lawful commercial activities under National Law.
 - b. Issued under the regulatory framework of the **Moorish National Republic of Peace Economic Development Authority**.

SECTION 4: VALIDITY, RENEWAL, AND SECURITY OF IDENTIFICATION DOCUMENTS

1. **Validity and Renewal:**
 - a. All identification documents issued by the Republic shall have a validity period as follows:
 - **National Identification Card** – 10 years
 - **Passport** – 10 years
 - **Travel Credentials** – 5 years
 - **Elector Identification Card** – 5 years
 - **Business & Commercial License** – 3 years
2. **Renewal Requirements:**
 - a. Nationals and Citizens must apply for renewal **prior to expiration**.
 - b. Identification documents shall be renewed only after verification and authentication by the **Ministry of Records and Identification**.
3. **Security Features:**
 - a. All documents shall be embedded with **holographic seals, biometric verification, and**

encrypted serial numbers.

b. Unauthorized possession or duplication of these security features shall be deemed a **criminal offense.**

SECTION 5: PROHIBITED USE AND UNAUTHORIZED POSSESSION

1. Unauthorized Use:

a. No person shall falsely claim **Moroccan Nationality** or **Citizenship** through fraudulent means.

b. Possession of identification documents by **non-Nationals** without authorization is prohibited.

2. Forgery and Fraud:

a. Any person found guilty of producing, possessing, or using falsified **Moorish National Republic of Peace Identification Documents** shall be subject to penalties outlined in **Section 6.**

3. Loss or Theft Reporting:

a. All lost or stolen documents must be **immediately** reported to the **Ministry of Records and Identification.**

SECTION 6: PENALTIES AND LEGAL ENFORCEMENT

1. Criminal Penalties for Violations:

a. Forgery, Misrepresentation, or Fraudulent Use:

- Fine up to **100,000 Noble Dollars**
- Imprisonment up to **10 years**
- Permanent revocation of the right to obtain an **MNRP** identification document

b. Unauthorized Possession or Use by a Non-National:

- Fine up to **50,000 Noble Dollars**
- Imprisonment up to **5 years**
- Immediate deportation from **Moorish National Republic of Peace Jurisdiction**

2. Judicial Oversight:

a. Cases involving fraudulent identification shall be tried before the **Moorish National Republic of Peace Court of Justice.**

b. The **Chief Justice** shall have jurisdiction over all cases related to identity fraud and misrepresentation.

SECTION 7: INTERNATIONAL RECOGNITION AND DIPLOMATIC STATUS

1. Global Recognition of Identification:

- a. The **Moorish National Republic of Peace Passport** shall be presented before all **nations and international bodies** for formal recognition under the **Law of Nations**.
- b. **International agreements and treaties** shall be pursued to uphold the legitimacy and validity of Moroccan National Identification.

2. Diplomatic Agreements and Protections:

- a. The **Moorish National Republic of Peace** may engage in **bilateral and multilateral agreements** for mutual recognition of identification documents.
- b. All diplomatic personnel shall be issued **Special Identification Credentials** ensuring protections under **International Law**.
