TO ESTABLISH INTERNATIONAL ROAD TO TRAFFIC LAW

Pursuant to the Moorish National Republic of Peace Amendment 18, Section 2, Clause 2, wherein it states; “The Moorish National Republic of Peace shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the Moorish National Republic of Peace, or any Department or Officer thereof”, there shall hereby be designated “International Road to Traffic Law” provisions to serve this purpose. This Public law shall go into immediate force.

PURPOSE

The **Moorish National Republic of Peace (MNRP)** hereby establishes **Traffic Law** under the **sovereign jurisdiction** of the Republic to regulate road travel, commercial conveyance, and the rights of Moroccan Nationals within **MNRP-controlled territories and international agreements**. This law affirms the natural right to travel, establishes **road governance**, and protects individuals against unlawful detainment and commercial regulation of private travel.

RIGHT TO TRAVEL

The right to **unrestricted travel** is a **God-given right**, recognized under **international law** and upheld by the **MNRP Court of Justice**. Moroccan Nationals and citizens of the **MNRP** retain the full right to use public roadways **without being forced into commercial contracts**.

1.1 Travel vs. Commercial Driving

The **MNRP** recognizes two primary distinctions in road usage:

1. **Private Travel** – The act of moving freely from one place to another without engaging in commerce.
2. **Commercial Driving** – The operation of a motor vehicle for business, profit, or transport services, subject to commercial regulation.

Only **commercial drivers** engaging in regulated transport shall be subject to commercial licensing requirements. All Moroccan Nationals have the right to **private travel** free from commercial restrictions.

NATIONAL IDENTIFICATION AND TRAVEL DOCUMENTATION

All Moroccan Nationals traveling under the **Moorish National Republic of Peace** jurisdiction shall be issued a **National Identification and Travel Card**, recognized as a lawful form of identification.

2.1 National Identification and Travel Card

The **National Identification and Travel Card** shall:

- Serve as **legal proof** of nationality under **MNRP jurisdiction**.
- Confirm that the bearer has **the right to travel freely**.
- Be **exempt from State-issued licenses** that impose commercial restrictions on private travel.

- Identify the holder as a **Moroccan National** of the **MNRP**.

2.2 Registration of Vehicles to Private Trusts

Vehicles used by Moroccan Nationals may be **registered under Private Trusts** to prevent unlawful commercial claims by external jurisdictions. The **MNRP recognizes private conveyances** as property under sovereign ownership, not subject to licensing or taxation by foreign governments.

TRAFFIC ENFORCEMENT UNDER MNRP JURISDICTION

3.1 Authority of MNRP Court of Justice

The **MNRP Court of Justice** has exclusive jurisdiction over Moroccan Nationals concerning:

- **Unlawful detainment for non-commercial travel**
- **Unlawful ticketing or taxation of travel**
- **Challenges to foreign jurisdictions imposing commercial regulations**

3.2 Recognition of MNRP Travel Rights by Foreign Entities

The Ministry of Foreign Affairs & Diplomatic Relations shall establish international agreements and diplomatic relations to ensure the recognition of the Moorish National Republic of Peace (MNRP) and the unrestricted right of travel for all Moroccan Nationals. Any foreign government or agent that attempts to interfere with or restrict this right shall be deemed in violation of international human rights law, treaty obligations, and the sovereignty of the MNRP. The enforcement of such violations shall be carried out through lawful diplomatic channels and, where necessary, brought before the Court of Justice for remedy.”

PROHIBITIONS AND VIOLATIONS

4.1 Unlawful Roadside Detainment

- No Moroccan National may be stopped, detained, or questioned for **traveling in a private capacity** unless **reasonable suspicion of a crime exists**.
- Law enforcement agencies from external jurisdictions **shall not impose commercial traffic laws** upon Moroccan Nationals.
- Any officer engaging in **unlawful detainment** shall be charged with **Violation of Sovereign Immunity** under **MNRP Law**.

4.2 Unlawful Vehicle Confiscation

- Vehicles privately registered under **MNRP Trusts** shall **not be seized** by any foreign government or corporate entity.
- Any attempt to confiscate property without **due process under MNRP Law** shall constitute **Theft by Conversion**.

4.3 Unlawful Ticketing and Fines

- Moroccan Nationals are **not required to pay fines or fees** related to **commercial traffic laws** unless they are actively engaged in commerce.
 - Any issuance of **tickets for private travel** shall be voided under **MNRP Law**.

ENFORCEMENT OF INTERNATIONAL ROAD TO TRAFFIC LAW

5.1 Sovereign Protections

- Moroccan Nationals who **invoke their sovereignty** shall be **protected under MNRP jurisdiction**.
- Law enforcement officers must **honor all MNRP-issued travel credentials**.
- Any violation shall be prosecuted under **MNRP Court of Justice**.

5.2 International Recognition and Treaties

- The **MNRP shall enter into treaties** ensuring that Moroccan Nationals may **travel internationally** without restrictions.
 - Any refusal to recognize MNRP travel rights by a foreign state shall be considered a **violation of international law**.

OFFICIAL RECOGNITION

This Act establishes the **MNRP Court of Justice** as the **sole lawful authority** over all **road travel matters** concerning Moroccan Nationals.

All travel credentials shall be issued under the **Registrar of National Affairs** and stored in the **National Archives of the MNRP**.
