Supreme Religious Council Noble Dollar and Noble Stamp Act



TO ESTABLISH NOBLE DOLLAR AND NOBLE DOLLAR STAMP ACT

Pursuant to the Moorish National Republic of Peace Amendment 18, Section 2, Clause 2, wherein it states; “The Moorish National Republic of Peace shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the Moorish National Republic of Peace, or any Department or Officer thereof”, there shall hereby be designated “Noble Dollar and Noble Stamp Act” provisions to serve this purpose. This Public law shall go into immediate force.

NOBLE DOLLAR AND NOBLE DOLLAR STAMP ACT

TITLE I - MONETARY SYSTEM

CHAPTER 1 - ESTABLISHMENT OF NOBLE DOLLAR

Section 1. Definition and Recognition of the Noble Dollar

- (a) The **Noble Dollar** is established as the official currency of the **Moorish National Republic of Peace**, recognized for all lawful exchanges, trade, and commercial transactions within and beyond its territorial jurisdiction.
- (b) The Noble Dollar shall be backed by lawful tender, including but not limited to silver, commodities, and services, and shall be issued under the full faith and credit of the **Moorish National Republic of Peace Treasury**.
- (c) The Noble Dollar shall have the following denominations: **1 Noble, 5 Nobles, 10 Nobles, 20 Nobles, 50 Nobles, 100 Nobles, 500 Nobles, and 1000 Nobles**.
- (d) The Noble Cents shall be established as fractional units of the Noble Dollar, with the following denominations: **1 Noble Cent, 5 Noble Cents, 10 Noble Cents, 25 Noble Cents, and 50 Noble Cents**.

Section 2. Issuance and Circulation of Noble Dollar

- (a) The **MNRP Treasury** shall have exclusive authority over the issuance, printing, and distribution of the Noble Dollar and Noble Cents.
- (b) The Noble Dollar and Noble Cents shall be available in both physical and digital formats, with security measures ensuring authenticity and protection against counterfeiting.
- (c) The exchange rate and valuation of the Noble Dollar shall be determined based on the sovereign economic policies of the **Moorish National Republic of Peace**, ensuring stability and self-sustainability.
- (d) The Noble Dollar shall be **interest-free** and shall not be issued under debt-based financial systems.

Section 3. Legal Tender Status of Noble Dollar

- (a) The Noble Dollar and Noble Cents shall be recognized as **legal tender** for all debts, public charges, taxes, and dues within the jurisdiction of the **Moorish National Republic of Peace**.
- (b) No individual, entity, or foreign government shall be required to accept any currency other than the Noble Dollar within the jurisdiction of the MNRP, except by treaty agreement.

(c) All government transactions, contracts, and financial dealings shall be conducted in Noble Dollars.

CHAPTER 2 - ESTABLISHMENT OF THE NOBLE STAMP

Section 4. Definition and Recognition of the Noble Stamp

(a) The **Noble Stamp** shall be issued by the **MNRP Postmaster General** as an official recognition of sovereign postal authority and communication.

(b) The Noble Stamp shall be used exclusively for official Moorish National Republic of Peace postal services, securing correspondence and official documents.

Section 5. Issuance and Regulation of the Noble Stamp

(a) The **MNRP Postmaster General** shall oversee the production, issuance, and regulation of the Noble Stamp.

(b) The Noble Stamp shall be affixed to all government-certified mail, official court documents, and international correspondence of the **Moorish National Republic of Peace**.

(c) The denominations of the Noble Stamp shall be established based on postal service needs and shall be issued in values of **1, 5, 10, 20, and 50 Nobles**.

Section 6. Protection Against Counterfeiting and Fraud

(a) Any unauthorized reproduction, forgery, or misuse of the Noble Dollar, Noble Cents, or Noble Stamp shall be considered **an act of fraud** and subject to strict penalties under MNRP law.

(b) The **MNRP Security Office** shall monitor all activities relating to the Noble Dollar, Noble Cents, and Noble Stamp, ensuring compliance with national and international regulations.
