


# MOORISH NATIONAL REPUBLIC OF PEACE

## Supreme Religious Council

### Public Law 111-11



#### TO ESTABLISH NATIONAL PROTECTION OF INTELLECTUAL PROPERTY, TRADENAMES, AND TRADEMARKS

**Pursuant to the Moorish National Republic of Peace Constitution (2025), Amendment XVIII, Section 3, wherein it states:**

*"The Moorish National Republic of Peace shall make all Laws which shall be necessary and proper for carrying out the powers vested in its government, departments, and officers under this Constitution,"*

**There shall hereby be designated National Protection of Intellectual Property, Tradenames, and Trademarks provisions to serve this purpose.**

**This Public Law shall go into immediate effect.**

## SECTION I — DEFINITIONS

For the purposes of this law, the following definitions apply:

1. **Trademark:**  
Any word, name, symbol, insignia, seal, emblem, logo, or mark lawfully adopted by the MNRP to represent its authority, institutions, services, or initiatives.
2. **Tradenname:**  
The official or distinctive names of the Moorish National Republic of Peace and its governmental ministries, agencies, councils, departments, or affiliated programs.
3. **Copyright:**  
Any original written, visual, auditory, or creative work authored by or for the MNRP, including but not limited to government documents, publications, educational materials, audio recordings, artwork, digital content, ceremonies, and national declarations.
4. **Official Use:**  
Use by authorized officers, agents, departments, or representatives of the MNRP in carrying out official government functions, declarations, communications, or cultural expressions.
5. **Unauthorized Use:**  
Any reproduction, imitation, distribution, publication, or exploitation of MNRP intellectual property without written authorization from the Supreme Religious Council or its delegated authority.

## SECTION II — SOVEREIGN OWNERSHIP

1. All trademarks, tradenames, and copyrighted materials are the exclusive property of the Moorish National Republic of Peace, held in trust by the Supreme Religious Council for the benefit of all Moroccan Nationals.
2. Ownership is perpetual, non-transferable, and inheritable by future generations of the Nation, unless expressly authorized by law or treaty ratified by the Supreme Religious Council.
3. No individual, corporation, foreign state, or entity may claim ownership, co-ownership, or proprietary interest in MNRP intellectual property.

## SECTION III — REGISTRATION & RECORDING

1. The **Ministry of Records & National Archives** shall serve as the official registry for all national trademarks, tradenames, and copyrighted works.

2. All creations, emblems, and marks originating under MNRP jurisdiction shall be registered and archived for official recordation.
3. The Registry shall maintain public access for verification of authenticity and lawful use, as determined by the Supreme Religious Council.

## SECTION IV — PROTECTIONS AND RESTRICTIONS

1. Unauthorized use of MNRP intellectual property is strictly prohibited.
2. Any party, foreign or domestic, found to be misusing, counterfeiting, reproducing, or commercially exploiting MNRP intellectual property shall be subject to enforcement actions under this law.
3. Forgery or counterfeit of the national seal, emblems, or official documents is classified as **High Treason**, punishable under MNRP law.
4. Use of MNRP intellectual property in any manner that brings disrepute, fraud, or deception upon the Nation shall be prosecuted.

## SECTION V — LICENSING AND AUTHORIZED USE

1. The **Supreme Religious Council** retains sole authority to license the use of MNRP intellectual property, either directly or through authorized ministerial delegation.
2. The Council may authorize third-party usage for educational, cultural, diplomatic, or lawful commercial purposes, provided it serves the interests of the Nation.
3. Any license granted shall be documented in the official records of the **Ministry of Records & National Archives**, and shall include clear terms of duration, scope, and revocation rights.
4. All authorized use must display the following designation:

"Used under the authority of the Moorish National Republic of Peace."

## SECTION VI — ENFORCEMENT

1. The **Court of Justice of MNRP** shall have full jurisdiction over violations of this law.
2. Enforcement actions may include:
  - Injunctions and cease-and-desist orders;
  - Confiscation and destruction of counterfeit goods;
  - Civil penalties and reparations;

- Criminal prosecution for treasonous or fraudulent actions.
  - 3. The **Ministry of Information & Technology** shall monitor and enforce digital and online protection of intellectual property, including cyber security and international digital platforms.
  - 4. The **Ministry of Foreign Affairs** shall formally notify foreign governments and international bodies of this law, and pursue enforcement actions through diplomatic channels where violations occur abroad.

## **SECTION VII — INTERNATIONAL PROTECTIONS**

1. The MNRP asserts its sovereign right to protect its intellectual property under the Law of Nations, and customary international law.
  2. The **Ministry of Foreign Affairs** shall engage with international bodies, including the African Union, the World Intellectual Property Organization (WIPO), and other diplomatic forums to ensure recognition and protection of MNRP intellectual property worldwide.
  3. The MNRP reserves all rights to pursue remedies under international agreements and principles, and shall enforce these rights to the fullest extent permitted by international law.

## **SECTION VIII — FINAL PROVISIONS**

1. This law takes immediate effect upon ratification and shall remain in force indefinitely as part of the supreme laws of the Moorish National Republic of Peace.
  2. The Supreme Religious Council shall issue further decrees as necessary to implement, enforce, and refine the provisions of this law.
  3. No foreign law, statute, or decree shall supersede the authority of this law within MNRP jurisdiction or in relation to its interests abroad.

## **ENACTED AND RATIFIED**

**Signed into Law on APRIL 20<sup>TH</sup>, 2025**

**By Authority of the Moorish National Republic of Peace Government**
