# **Board of Directors Assembled Republic Rules and Civil Procedure**



#### TO ESTABLISH REPUBLIC RULES AND CIVIL PROCEDURE

Pursuant to the Moorish National Republic of Peace Constitution Amendment 18, Section 2, Clause 2, wherein it states; "The Moorish National Republic of Peace shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the Moorish National Republic of Peace, or any Department or Officer thereof", there shall hereby be designated "Republic Rules and Civil Procedure" provisions to serve this purpose. This Public law shall go into immediate force.

### REPUBLIC RULES AND CIVIL PROCEDURES

- 1. Civil Action is the Only Action. Let us exercise daily Love, Truth, Peace, Freedom, and Justice.
- 2. All complaints are to be filed with the Moorish National Republic of Peace Discipline Committee. The clerk of the Court of the Discipline committee shall file the complaint on the Docket of the court. The clerk shall give each case a number according to its cause.
- 3. The Plaintiff bringing the complaint must deliver all documents by mail to the Moorish National Republic of Peace, by Certified or Registered mail Return Receipt.
- 4. The Plaintiff bringing the complaint must deliver all documents by mail to the defending party, by Certified or Registered mail Return Receipt. The Plaintiff after notifying the Defendant must file proof of service with the clerk of the Court.
- 5. The Defendant has 30 days from the day of receiving the complaint from the Plaintiff to answer to the Court of the Moorish National Republic of Peace. If the Defendant do not answer within 30 days automatically silence is consent, the defendant shall fall into default. The defendant may motion the court for extended time to present a rebuttal. The Defendant must answer by Certified or Registered mail Return Receipt.
- 6. The Defendant has the right at rebuttal to make a counter claim against the Plaintiff for all grievances caused.
- 7. In any court of the Moorish National Republic of Peace "Truth" stands as Sovereign.
- 8. After being presented with affidavits from both parties, the Discipline committee will present the case to the Jurist and Chairman of the Discipline Committee. The Jurist and Chairman must decide if the case holds any merit.
- 9. The Chairman and Discipline committee will decide on the Judgement according to the Laws of the Moorish National Republic of Peace.
- 10. Any Judgments can be appealed and must be filed with the President of the Provinces or the President of the Moorish National Republic of Peace.



- 11. All Courts of the Moorish National Republic of Peace are courts of equity. The courts has jurisdiction to hear any and all cases of subject matter to the Moorish National Republic of Peace.
- 12. If Jury Trial is Requested, the defendant has the right to receive a jury of their society.
- 13. All Parties involved in any case must provide sureties for liabilities related to cases.
- 14. All Members of the Court must have a bond and oath to the Constitution for the Moorish National Republic of Peace.
- 15. Both parties may see the Jurist of the Discipline Committee for Lawful advice due to their cases only.
- 16. Any violations of the court such as: Misconduct in the presence of the court which interferes with a court proceeding or with administration of justice, or which impairs the respect due to the court; disobedience, resistance or obstruction of the authority, process or order of a court; refusal as a witness to appear, be sworn or answer a question is contempt of court and punishable by jail or fine, both.
- 17. Only the Chairman of the Discipline Committee can impose a contempt sanction.
