Supreme Religious Council Right to Travel Act



TO ESTABLISH THE RIGHT TO TRAVEL ACT

Pursuant to the Moorish National Republic of Peace Amendment 18, Section 2, Clause 2, wherein it states; "The Moorish National Republic of Peace shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the Moorish National Republic of Peace, or any Department or Officer thereof", there shall hereby be designated "The Right to Travel Act" provisions to serve this purpose. This Public law shall go into immediate force.

CHAPTER 1 - DECLARATION OF RIGHTS

Section 1. Recognition of the Right to Travel

- (a) The **Moorish National Republic of Peace** recognizes the **unalienable right** of all Moroccan Nationals to **travel freely** by any means necessary, without restriction, license, or permit, as a **God-given liberty** protected by Natural Law, the Law of Nations, and the Constitution of the **Moorish National Republic of Peace**.
- (b) The right to travel shall not be **infringed** or **converted into a commercial privilege** requiring any registration, taxation, or licensure under foreign jurisdiction.

Section 2. Jurisdiction and Authority

- (a) The **Moorish National Republic of Peace** has full jurisdiction over its Nationals in matters of **private travel** within its dominion and shall not recognize foreign statutes that restrict the lawful movement of Moroccan Nationals.
- (b) Moroccan Nationals are exempt from any foreign or domestic jurisdiction **imposing commercial codes** upon their private travel affairs.
- (c) The use of MNRP-issued identification, travel credentials, and registration shall serve as valid documentation under international and national law to identify Moroccan Nationals and their lawful travel status.

CHAPTER 2 - IMPLEMENTATION AND PROTECTION

Section 3. Enforcement of the Right to Travel

- (a) Any entity, foreign or domestic, attempting to **impede**, **detain**, **fine**, **or arrest** a Moroccan National for exercising their right to travel shall be deemed in **violation of international human rights law** and held accountable under the **MNRP Court of Justice**.
- (b) The **MNRP Security and Protection Force** is hereby vested with the power to ensure the safe passage of Moroccan Nationals and enforce their right to travel free from external interference.



(c) Moroccan Nationals shall be entitled to **full legal recourse** in cases of unlawful detainment, citation, or restriction of travel and may file claims for damages.

CHAPTER 3 - DOCUMENTATION AND IDENTIFICATION

Section 4. Issuance of Travel Credentials

- (a) The MNRP Identification Bureau shall issue National Travel Cards, Diplomatic Identification, and Travel Exemptions for Moroccan Nationals.
- (b) Such credentials shall serve as **official proof** of Moroccan National status and exemption from foreign travel restrictions.
- (c) Any foreign or domestic authority refusing to recognize such credentials shall be subject to **legal action** under the **MNRP Court of Justice**.
