### Supreme Religious Council Assembly Repatriation Act



#### TO ESTABLISH REPATRIATION ACT

Pursuant to the Moorish National Republic of Peace Constitution (2025), Amendment XVIII, Section 3, wherein it states:

"The Moorish National Republic of Peace shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the Moorish National Republic of Peace, or any Department or Officer thereof", there shall hereby be designated Repatriation Act provisions to serve this purpose.

This Public Law shall go into immediate effect.

## MOORISH NATIONAL REPUBLIC OF PEACE REPATRIATION ACT

#### **CHAPTER 1 - PURPOSE AND AUTHORITY**

#### Section 1. Recognition of Repatriation Rights

- (a) The **Moorish National Republic of Peace** acknowledges the inherent right of all **Moroccan Nationals** (formerly misclassified as Black, African American, Negro, Colored, Hispanic, Puerto Rican, Jamaican, Haitian, and Latino) to repatriate under the jurisdiction of the **Moorish National Republic of Peace**.
- (b) The Moorish National Republic of Peace shall repatriate **Moroccan Nationals** and all their assets, estates, and items of symbolic value back to their lawful status under **Moorish National Law**.

#### **Section 2. Status Definitions**

- (a) **Moroccan Nationals** Individuals who have pledged their allegiance to the **Moorish National Republic of Peace** and declared their nationality as Moroccans. These individuals are recognized as full members of the Republic.
- (b) Citizens Moroccan Nationals who have not made the Moorish National Republic of Peace a Trustee over their private trust but retain all civil protections and rights under the Republic.
- (c) **Residents** Individuals who are domiciled within the jurisdiction of the **Moorish National Republic of Peace**, protected by its laws but not full Nationals. Residents do not have voting rights in national matters.
- (d) **Non-Moroccan Residents** Individuals not of **Moroccan bloodline**, who, while under the jurisdiction of the **Moorish National Republic of Peace**, must abide by its laws but cannot participate in governance or hold office.
- (e) **Subjects** All individuals under the legal protections and jurisdiction of the **Moorish National Republic of Peace**, including Moroccan Nationals, Citizens, and Residents.

#### **CHAPTER 2 - DELEGATION OF AUTHORITY**

#### **Section 3. Administration of Repatriation**

(a) The **Moorish National Republic of Peace** delegates authority to the appropriate governmental department to oversee the nationalization and registration of all Moroccan Nationals repatriating to the Empire of Morocco under the Republic's jurisdiction.

(b) This act shall apply to all Provinces of the **Moorish National Republic of Peace**, ensuring uniform repatriation procedures.
