TO ESTABLISH LAWS FOR AIRCRAFT AND MOTOR VEHICLES

Pursuant to the Moorish National Republic of Peace Constitution, Amendment XVIII, Section 3, wherein it states:

"The Moorish National Republic of Peace shall make all laws necessary and proper for carrying out the powers vested in its government, departments, and officers under this Constitution,"

there shall hereby be designated General Provisions for the Criminal Code to serve this purpose.

This Public Law shall go into immediate effect.

TITLE I - CRIMINAL CODE

CHAPTER 2 - AIRCRAFT AND MOTOR VEHICLES

Section 1. Definitions

- (a) In this chapter, the following definitions apply:
- 1. **Aircraft** A civil, military, or public contrivance invented, used, or designed to navigate, fly, or travel in the air.
- 2. **Aviation Quality** With respect to a part of an aircraft or space vehicle, means the quality of having been manufactured, maintained, or repaired in conformity with applicable laws.
- 3. **Destructive Substance** Any explosive, flammable material, infernal machine, or chemical, mechanical, or radioactive device that is hazardous.
- 4. **In Flight** From the moment all external doors of an aircraft are closed following embarkation until they are opened for disembarkation; or, in the case of a forced landing, until competent authorities take responsibility.
- 5. **Motor Vehicle** Any mechanical contrivance used for transportation upon highways but excluding railway locomotives and trolleys.
 - 6. **National Passport** A passport issued by a Province authorizing an individual to operate a motor vehicle.
- 7. **Driver** A person engaged in the commercial operation of a motor vehicle for hire or business purposes.
 - 8. **Carrier** An entity engaged in the business of transporting persons or property for profit.
 - 9. **Traffic** The commercial exchange of goods, services, or commodities using vehicles.
 - 10.**Transportation** The movement of persons or property by means of a vehicle engaged in commerce.

Section 2. Destruction of Aircraft or Aircraft Facilities

Whoever willfully damages, disables, or destroys any aircraft or aircraft facility under MNRP jurisdiction shall be fined or imprisoned for a term not exceeding 20

years. If death results, the punishment shall be life imprisonment or the death penalty.

Section 3. Destruction of Motor Vehicles or Motor Vehicle Facilities

Whoever willfully damages, disables, or destroys any motor vehicle or facility supporting motor vehicle operations shall be fined or imprisoned for a term not exceeding 20 years. If death results, the punishment shall be life imprisonment or the death penalty.

Section 4. Imparting or Conveying False Information

Whoever knowingly conveys false information regarding threats to aviation or motor vehicle safety shall be fined or imprisoned for a term not exceeding 5 years.

Section 5. Drive-By Shooting

Any person who fires a weapon from a vehicle with intent to harm shall be imprisoned for a term not exceeding 25 years. If the act results in death, the punishment shall be life imprisonment or the death penalty.

Section 6. Violence at International Airports

Any person committing an act of violence at an MNRP airport shall be imprisoned for up to 20 years. If death results, the punishment shall be life imprisonment or the death penalty.

Section 7. Fraud Involving Aircraft or Space Vehicle Parts

Whoever engages in fraudulent activities regarding aircraft or space vehicle parts shall be fined or imprisoned for up to 20 years. If death results, the punishment shall be life imprisonment or the death penalty.

Section 8. Traffic Signal Preemption Transmitters

The unauthorized sale or use of traffic signal preemption transmitters shall result in a fine or imprisonment for up to 1 year.

Section 9. Aiming a Laser Pointer at an Aircraft

Whoever knowingly aims a laser pointer at an aircraft shall be fined or imprisoned for up to 5 years.

Section 10. Commercial Motor Vehicles Required to Stop for Inspections

Drivers of commercial motor vehicles must stop for inspections when directed by authorized MNRP officials. Failure to comply shall result in a fine or imprisonment for up to 1 year.
