Supreme Religious Council Treasurer Act



TO ESTABLISH MINISTER OF TREASURER AND NATIONAL ECONOMY ACT

Pursuant to the Moorish National Republic of Peace Constitution, Amendment XVIII,
Section 3, wherein it states:

"The Moorish National Republic of Peace shall make all laws necessary and proper for
carrying out the powers vested in its government, departments, and officers under this
Constitution,"

There shall hereby be designated the "Treasurer Act" provisions to serve this purpose.
This Public Law shall go into immediate effect upon ratification.

TREASURER ACT

ARTICLE I - AUTHORITY AND JURISDICTION

1. The **Minister of Treasurer and National Economy of the Moorish National Republic of Peace** shall serve as the **Chief Financial Officer** of the National Treasury, responsible for the management and oversight of all financial affairs within the Nation-State.
2. The Minister of Treasurer and National Economy (Treasurer) shall be responsible for the **collection, safekeeping, investment, and disbursement** of the financial assets of the Republic, ensuring all funds are used in accordance with National Law and for the benefit of the People.
3. The Treasurer shall oversee the establishment of **National Financial Institutions**, including but not limited to:
 - The **Moorish National Treasury Bank**
 - The **Moorish National Reserve System**
 - The **Moorish National Development Fund**
4. The Treasurer shall regulate the issuance of the **Noble Dollar** and ensure it remains backed by tangible assets and national resources.

ARTICLE II - NATIONAL ACCOUNTS AND FUND MANAGEMENT

1. All accounts of the **Moorish National Republic of Peace** shall be opened in the name of the **National Treasury**.
2. Only the **Treasurer and the Head of State** shall be authorized signatories on all National Accounts. No external entity shall have authority over such accounts.
3. The Treasurer shall keep full and accurate records of:
 - All **National Revenues and Expenses**
 - **Foreign and Domestic Investments**
 - **Trusts and Special Allocations**
4. The Treasurer shall prepare and present an **Annual Budget Report** to the Board of Directors and the Nation-State's Governing Assembly.

ARTICLE III - DELEGATION OF AUTHORITY

1. The **Moorish National Republic of Peace Religious Supreme Council** hereby delegates full financial authority to the **Office of the Minister of Treasurer and National Economy** to:
 - Establish **Monetary Policies** in alignment with the National Constitution.
 - Regulate **financial exchanges and currency issuance**.
 - Supervise **investment portfolios** and revenue allocations.
2. The Treasurer shall have oversight over the **National Bureau of Revenue Collection** and **National Bureau of Economic Development**.
3. The Treasurer shall coordinate with other National Departments for the equitable distribution of funds and financial resources.

ARTICLE IV - ENFORCEMENT OF FINANCIAL LAWS

1. Any individual, entity, or province conducting unauthorized financial transactions under the name of the **Moorish National Republic of Peace** shall be held liable under **Republic Law** and subject to penalties.
2. Any misuse of National Treasury funds shall be classified as **financial treason**, subject to **investigation, prosecution, and restitution**.
3. The Treasurer shall have the authority to **audit any financial institution** operating under the National Republic to ensure compliance with lawful financial practices.
4. All financial reports and transactions of the Republic shall be transparent and open for review by the **Religious Supreme Council and the Nation's Citizens**.

ARTICLE V - RATIFICATION AND IMPLEMENTATION

This Act shall take effect immediately upon official declaration and ratification by the **Religious Supreme Council and Head of State of the Moorish National Republic of Peace**.
