Supreme Religious Council Assembly The Sovereign Birthright and Lineage Preservation Act



TO ESTABLISH THE SOVEREIGN BIRTHRIGHT AND LINEAGE PRESERVATION ACT

Pursuant to the Moorish National Republic of Peace Constitution (2025), Amendment XVIII, Section 3, wherein it states:

"The Moorish National Republic of Peace shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the Moorish National Republic of Peace, or any Department or Officer thereof," there shall hereby be designated The Sovereign Birthright and Lineage Preservation Act to serve this purpose.

This Public Law shall go into immediate force.

PURPOSE

The **Moorish National Republic of Peace (MNRP)**, duly assembled, acknowledges and affirms the **sovereign birthright and lineage** of each **Moroccan National** born within the jurisdiction of the Republic. This Act serves to **preserve ancestral heritage, lineage, and sovereign status**, ensuring that all live births are properly recorded and protected under the law.

AUTHORITY TO PRESERVE SOVEREIGN LINEAGE

The **Moorish National Republic of Peace**, under the **constitutional authority granted in Amendment XVIII, Section 3**, recognizes the **inherent right** of each child born within the Nation to **claim their birthright** as a sovereign individual. The preservation of this lineage shall be duly recorded and safeguarded by the **Registrar of Births**, responsible for maintaining all live birth records under the jurisdiction of the MNRP.

DELEGATION OF AUTHORITY TO THE REGISTRAR

The **Moorish National Republic of Peace** delegates the authority of the **Registrar of Births** to maintain, preserve, and oversee the live birth records of all **Moroccan Nationals**. The **Registrar** is entrusted with the **sacred duty** of documenting each birth as part of the **collective ancestral heritage**, ensuring the **legitimacy and recognition** of each record within the **MNRP**. These records shall be held in **perpetuity** as proof of **lineage** and as **legal instruments** affirming an individual's **sovereign status** under the protection of the **MNRP**.

PRESERVATION OF RECORDS

All live birth records, once documented by the **Registrar of Births**, shall be recognized as **official documents** of the **Moorish National Republic of Peace**. These records shall ensure the individual's **God-given rights, liberties, and connection to their ancestral heritage**. They also serve as **legal instruments** within the Republic, providing the foundation for:

- **Inheritance**
 - **Identity**
 - **Sovereign recognition across all relevant jurisdictions**

DIVINE RECORD

1.1 Definition

A **Divine Record** is any **valid and duly authorized record** entered into the **Great Register and Public Record** of the **Moorish National Republic of Peace** in accordance with:

- **The Covenant with the Most High**
- **MNRP Laws and Constitution**

A **Divine Record** is the **highest** and **most superior** form of all records. Once created, it **cannot be undone**.

1.2 Divine Trust

A **Divine Trust** is a **Spiritual Ecclesiastical Trust** validly registered into the **Great Register and Public Record** of the **MNRP** containing **actual spiritual form** as well as **Divine Property**, administered by the **Treasury of the Moorish National Republic of Peace**.

A **Divine Trust** holds **actual Form**, unlike other **Trusts** that only hold **Rights of Use**.

LIFE RECORD

2.1 Definition

A **Life Record** is any **valid and duly authorized record** recognizing the **commencement of existence** entered into the **Great Register and Public Record** of the **Moorish National Republic of Peace**.

A **Life Record** is distinct from a **Divine Record**, as it is **temporary** and must eventually be transferred to become a **Death Record**.

2.2 Creation of Living Trusts

A **Life Record** is formed when:

- **Consciousness manifests its first breath**
- A **Living Trust** is created, categorized as one of the following:
 - **Superior True Trust:** The highest form of Living Trust, pre-existing in the **Divine Trust**.
 - **True Trust:** The second-highest form, containing the **Rights of Use** of Object and Concept.
 - **Temporary Trust:** A lower form, lasting no more than **720 days**.

VALID ISSUANCE OF LIVE BORN RECORD

2.3 Conditions for Issuance

A **Live Born Record** may only be issued under these conditions:

- **Affirmation sealed and witnessed** by two existing MNRP members that the individual cannot obtain a **birth record** from their previous jurisdiction.
- A **verified Ecclesiastical Affidavit of Truth** signed by a **Superior Official** of the MNRP.

2.4 Structure of a Valid Live Born Record

A **Live Born Record** shall:

1. Contain the **official seal** and name of the MNRP.
2. Clearly indicate that it is an **Abstract** from the **Great Register**.
3. Reference this **Act** as legal authority.
4. Contain the **individual's lineage**.
5. Be **sealed** by the **Registrar** and an **Official of the MNRP Supreme Court**.

ENFORCEMENT & PROTECTION

A **valid Live Born Record** is **proof of superior title** over all other **claimed registrations**. Any challenge to its legitimacy is a **legal contest of title**, preventing any other entity from **claiming rights over the individual**.

Unlawful attempts to deny, alter, or nullify a **Live Born Record** shall be prosecuted under the **Laws of the Moorish National Republic of Peace**.

OFFICIAL RECOGNITION

This Act establishes the **MNRP Registrar of Births** as the **sole lawful authority** over **sovereign birth records** within the Republic.

All recognized **Live Born Records** shall be stored in the **National Archives of the MNRP** and protected under **National Law**.
