General: As the dog-days of August approach, perhaps it's a good time to take stock of our year-to-date. As of our July attendance report, we had roughly 216 members. This number is constantly in flux as we gain new members – who experience a lag of as much as a month before they earn their member number – and sadly, as we lose members. That number is down just slightly from where it was about a year ago. Of those 216, roughly 75% have played at least one round and 40% have played more than 10 rounds. In all, we've played over 2,200 rounds of golf so far this year bringing in over \$70,000 to the local golfing economy! Go us!!

Member Guest: I want to remind everyone that the **deadline for** registering/paying for the Member-Guest at Lake Junaluska is August 15th. This event is shaping up to be more popular than anticipated, and early October at Lake Junaluska this year also appears to be more popular than anticipated. As I write this, we have 28 of our block of 30 rooms committed, though not all vet paid for (as I write this on July 18th, 10 have paid). While there are rooms available at the Terrace Hotel at Lake Junaluska beyond our block for days we're scheduled to be, our agent at Lake Junaluska will temporarily block several of the rooms that are still available at the Lambeth Inn (the other Hotel on the property). So there should be enough rooms to accommodate all who are interested. We will set the rooming list in order of receipt of registration/payment as well as by commitment indicated on the survey taken in March. Those who pay earliest will be more likely to get the room type they prefer as well as a room at the Terrace Hotel.

Regarding requests to arrive early or extend an extra day. These will be handled on a case by case, first-come, first-served basis until we run out of availability. Please DO NOT contact the reservations desk at Lake Junaluska directly. Rather, contact me with your request and I will put you in touch with our agent (not reservations) at Lake Junaluska. She will best be able to accommodate our needs. These exceptions will all be handled individually. You will be charged the same rate as our negotiated rate at the venue; however, you will pay individually for the additional nights. Do not include these additional nights in your payment to me with your registration. When you speak with our agent at Lake Junaluska, she will take your credit card information to hold, and eventually pay for, that room for the additional nights.



Golflink.com recently reported that there are about 60 golf courses, both public and private, within 20 miles of downtown Atlanta. This does not include some of the courses SGAA plays. Within the last 6 years, two courses we played have closed, and Cotton Fields may close later this year.


Quoting a February 2022 publication of the National Golf Foundation on golf course closings: "Golf courses are always going to close, such is the nature of any business. with an average footprint of about 150 acres, [courses] ... hold particular interest for developers. So, it's notable that the number of golf course closures in 2021 - 130.5 as measured in 18-hole equivalents – is down 53% from its peak two years ago, prior to the pandemic."

According to the report, more courses closed than opened every year between 2006 and 2020. The peak year for closings during that period was, surprisingly, pre-pandemic. In 2019, 2.1% of the to-tal US "18 hole equivalent supply" closed. In 2020 and 2021, closings were only 1.4% and 1% respectfully.

Cotton Fields Golf Club was developed by Jerry Schwendinger in the early 1990s and has been one of our key courses. Mr. Schwendinger also operated another course in Henry county and sold it to the county several years ago. The county later sold that course to a developer. He sold Cotton Fields to the county in 2008 and the county proposes to develop an aquatic park and office park on the property. The County Commission was scheduled to vote on the development proposal on July 18 but deferred action because of widespread resistance to the proposal.

Tina Murry has been with Cotton Fields since 2002. According to Tina, golf starts are now substantially above pre-pandemic levels. Despite increases in the cost of chemicals and equipment, the course is profitable. They have avoided the shortage of labor experienced by many other organizations as most of the employees have been at the course for several years.

There are rumors among golf professionals that other local courses are vulnerable to development. If this trend continues, our In Town Tournament Scheduling Committee will have to scramble.

There are a lot more details provided in the Survey Results report; but these are the most predominant items. The reasons for joining SGAA vary from member to member, but I'm sure the majority of us joined for golf, fellowship, and course variety.

How do we retain our members and grow our organization without addressing the main points of contention uncovered in the Survey?

The problem with the winter start times was addressed as soon as possible, we have agreements with each of the courses we play and couldn't automatically change our starting times. The new agreements included a change in our start times for the winter months.

Two-thirds of the respondents were interested in plaving a The top three reasons people joined SGAA: 1- Organized modified format from time to time. Here's an example of a member stepping up and driving it down the middle of the fairway. Harry Matthews answered the call with our Par 3 tournaments [next one is August 31st at Providence].

> Two of the changes the members wanted to see adopted tomorrow go hand in glove - "inside the leather" and integrity. I believe SGAA had a policy of *giving* you the putt if it was inside the leather of a normal putter for the 2016 and 2017 seasons. Yes, this "inside the leather" sped up the game; but the term "inside the leather" is a nebulous length. Most believed it as 18-24" which seems fine, but there's still a 6" differential. And as indicated by the Survey there are (or were) some members lacking integrity in their play. The allowance for a gimmie "inside the leather" was abandoned with the 2018 season because it would seem that some putter shafts were covered in leather from end to head.

> I touched on the time it takes to play a round of golf in last month's Newsletter. This seems to be a never ending complaint. And I'm afraid it's here to stay. EVERYONE has to do their own individual part to keep the pace of play at four hours. Yes, there will be times when a ball is lost and you fall three minutes behind while you search; but the other players in the group should play their ball and then assist in the search. If this happens, then you should pick up the pace on the next hole so you don't get out of position.

> Everyone complains about the long rounds; but so far, no one has offered an equitable solution.


It's great that you long hitters can get 250+ yards off the tee; but how good is your short game?

ANNUAL TOURNAMENT INFORMATION

Our Annual Tournament begins on Wednesday, September 6th at Bear Creek Golf Course. Tee time is 8:30 AM for all rounds of the tournament. There is a special one-time table fee of \$10.00 to be paid at the start of your tournament play. Green fees (\$36.00) are to be paid to the course before each round. There are 9 rounds scheduled for this tournament. You may play as many rounds during the tournament schedule as you like, but you <u>MUST</u> <u>PLAY</u> a minimum of 4 rounds to be considered as competing in the Annual Tournament. No matter how many rounds you complete during the Annual Tournament, your 4 best rounds will used to determine your tournament standing.

The standard pre-registration applies to the tournament. You do not have to enter the tournament to play. You may also just show up, notify the table of your intentions, get a hole assignment, and pay your green fee.

The following SGAA rules are provided as a refresher as we begin tournament play. Additional information may be provided by the Table Captains, or on the SGAA website, as the tournament progresses.

1. Rules of Play—USGA, PGA and local course rules shall govern play except as listed below. While SGAA Rules may seem to be very tolerant it is for the benefit of members of the Senior Golfers Association of Atlanta and to promote speedier play. Any member or members wishing to abide strictly by USGA and PGA rules are welcome to do so.

2. A PLAYER--May pick up to identify, clean or exchange a ball that comes to rest anywhere within the boundaries of the golf course and replace the ball one club length, or within one club length, no closer to the hole without penalty except on the green (see rule #3), or in a sand trap (see rule #4). The ball must be placed in the same general environment (1st cut, 2nd cut, rough, etc.) as it originally came to rest. If a ball cannot be played within one club length and still considered unplayable it can be moved any distance on a line of entry back towards the last point the ball was struck with a one stroke penalty.

3. ON THE GREEN—A player may mark the balls location and pick up to identify, clean or exchange his ball. Ball must be replaced at the mark where it was picked up.

4. SAND TRAP PLAY—If your ball is in a fairway bunker or greenside sand trap and lies in a foot print (human or otherwise), any untended sand marks from previous a player, or maintenance equipment, you can pick up your ball, rake the area of untended marks and replace your ball in the same spot without penalty. Also, any ball resting in water or mud can be pulled out and placed one club length no closer to the hole but still in the trap or bunker, without a penalty.

5. BALL OUT OF BOUNDS, UNPLAYABLE or LOST—When a ball is hit out of bounds, declared unplayable (see rule #2) or lost, after searching for a <u>maximum</u> of three (3) minutes, the player may place his ball any distance along the flight of the ball where the ball went out of bounds, is presumed lost or determined unplayable. A one (1)-stroke penalty shall be counted.

6. 14 CLUB RULE—Each player shall have no more than 14 clubs in his bag or face disqualification from that round. 7. DROP LOCATION—A ball hit into a water hazard must be marked off from the side of initial entry into that hazard as stated above (where the ball first crossed the yellow line).

8. GUEST PLAY—Members may bring a guest during the year except to the Annual Tournament, or other designated tournaments when published to the membership. However, members have priority in the event of a cart shortage. The cards for this foursome will be held by the table captain until all member players have checked in, holes and carts assigned. After this time, the foursome with a guest can be assigned a hole. As stated, in the event of cart shortage the guest will not be allowed to play and the remainder of that foursome has the choice of playing (if there are openings in a group) or not playing. Never will an SGAA member be asked to leave and a guest allowed to play.
