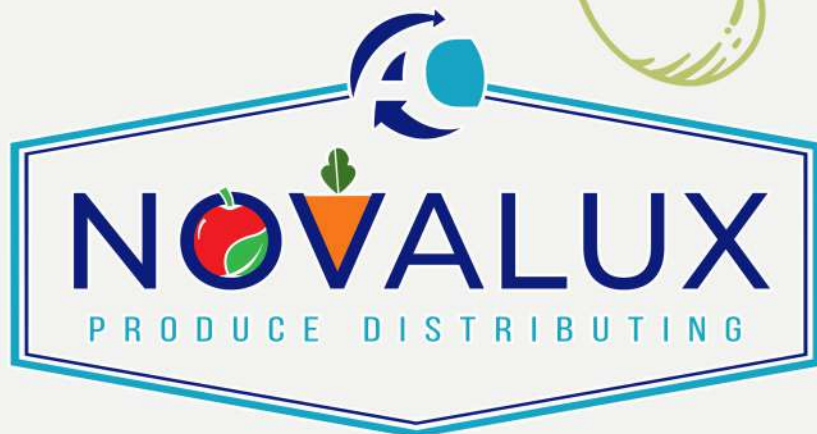

Purpose of Form
