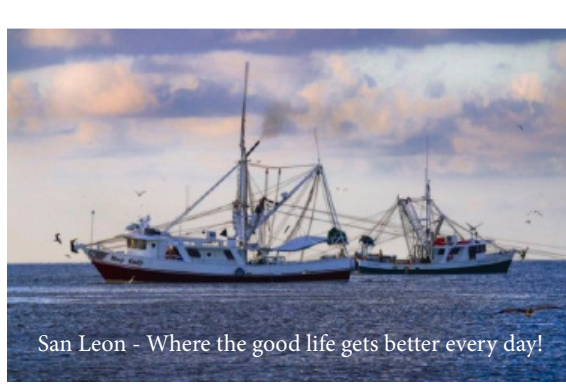

# FIREARM PURCHASES IN TEXAS

Seems like all we hear about lately is mass shootings, guns, ammo, multi round clips and assault rifles.

Many people wonder how someone can go into a gun store and buy a pistol or an assault rifle. Do they buy them illegally from these gun shops? The answer is no. Any businessperson selling firearms is not going to risk their livelihood making an illegal transaction for a few hundred dollars. There are many steps involved in the purchase of a gun from a licensed gun shop. First the business owner themselves must go through an extensive background check by the FBI. Once they are approved to obtain a FFL (Federal Firearms License), the cost will vary due to the different types of license. The license is good for 3 years and can be renewed for \$90.00. After someone sets up shop, there are specific rules and regulations they must follow. ATF Investigators DO go to the licensed shop to make sure they are in compliance. Being in compliance is a must! If the owner keeps bad records or is disorganized, they will be subject to a license revocation hearing in Houston.



When the background check and licensing steps are completed, the store is now ready to conduct business. A customer walks in and wants to purchase a handgun and they don't have a license to carry permit. The customer must provide a valid government-issued ID or driver's license. They then must fill out a 4473 form (Federal Document) that the owner of the store has obtained by ATF.

The 4473 form has about 35 boxes that the average person has to fill out. Name, current address, place of birth, height, weight, ethnicity, race, country of citizenship. Your social security number is optional. 12 of the boxes are questions. The questions can be found on ATF.GOV. Some of the questions consist of: Are you a felon? Are you a fugitive from justice? Are you addicted to drugs? (Yes, marijuana is a drug they list.) Have you ever been convicted in any court of a misdemeanor crime of domestic violence? Notably, Question F on form 4473 is: Have you ever been adjudicated as a mental defective or have you ever been committed to a mental institution? Keep in mind this is a federal document. If the purchaser answers "yes" to that, or any, question, the gun sale now stops and no guns may be purchased by that individual. If the customer answers "no," to all questions, you have to take them for their word for it at that point.

The customer now has to pass an FBI background check. The store owner can call it into NICS (National Instant Background Check System) or conduct the background check online through LEOP (Law Enforcement Enterprise Portal). They now give the FBI your name, place of birth, height, weight, and the other information on the form. They must also disclose whether it is a handgun, long gun, or other. The store owner does not disclose the manufacturer, importer, model, caliber, or the serial number. The background check does not register that handgun to the customer or divulge an address. The provided information is used to determine whether you are prohibited by Federal or state law from receiving a firearm. Falsifying information on the 4473 can result in 10 years in prison and /or up to a \$250,000.00 fine.

The store owner will receive 1 of 3 responses: Proceed, denied, or delayed. If you are delayed it can take up to 3 business days before you can pick up your firearms. On the 4th business day, if the store owner has not received a response from the FBI the store can now legally release the handgun to the customer. While the majority of background checks are completed within the 3-day time frame, almost all are completed within 30 minutes. There have been instances where the gun is released and then later found to be an ineligible release. Then there are gun shows. Most gun dealers at a gun show will do the FBI background check on any sale, but there are people that walk around with a few firearms and they will sell them without doing a background check. That is a loophole that should be addressed. If two or more handguns are purchased, additional paperwork must be sent to the FBI and the local law enforcement agencies.

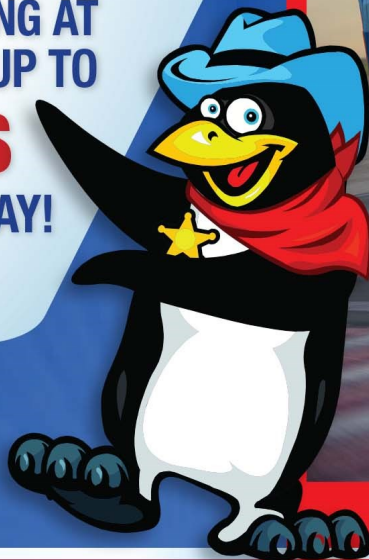

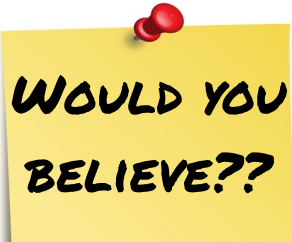

The Old House on 6th Street in San Leon was built in 1913 by Sam Saunders Sr. for a doctor from Chicago, IL. Evidently, the doctor's wife didn't care for life in San Leon. The house was vacant for many years and was used for a barn to store hay and house goats. In 1947, Sam Saunders, Jr. and his wife bought the house for back taxes. They restored the house and added a den across the back using the bottom
