TEXAS PARKS & WILDLIFE DELAYS VOTE ON BAY CLOSURES

The Texas Parks and Wildlife Commission has temporarily delayed a proposal to permanently close three bays for oyster harvesting, following roughly four hours of public testimony and more than 2,500 written comments. Environmental groups and biologists contend that bay closures are necessary for the protection of the oysters. Those who make their living harvesting them disagree.

The three bays facing closure are Carlos Bay, Mesquite Bay, and Ayres Bay near Rockport. The proposed amendment to close the bays stated, "The ecological importance and sensitivity of these oyster reefs coupled with the historically high harvest pressure and decreasing oyster abundance makes this minor bay complex a candidate for permanent closure from harvest."

Oyster fishermen, wholesalers and restaurant owners who came from all over the Texas coast disagree with how the state manages the reefs and worry about the financial impact on their industry. People in the industry speaking against the amendment said that closing the three bays will cause boats to overcrowd other areas, overwhelming those reefs as well. They blamed the state for poor management and said they too care about the reefs. "We care and want the bays to be prosperous," said Johny Jurisich, an oyster wholesaler in Galveston.

The Texas Parks and Wildlife chairman hopes to find a solution before oyster season reopens in November.



Dear Editor,

In March 2019 my husband, Joe Manchaca, wrote a letter to the editor addressing comments and statements that were said against our family. Now 3 years later I am writing a letter to the editor as my family is still being attacked by the same people. Joe passed away last year yet they are still calling him names on their public Facebook page which I understand is called the Bacliff/San Leon Buzz that one of them created, is the administrator of, doesn't live in either community, and allows these posted attacks. There is desperation when you try to smear a man who has passed away. Their favorite source of attack is name calling. Some of the name calling has to do with our last name as racial comments such as "the Manchaca Macheen" (which is a Hispanic mispronunciation of Machine), "the Manchaca crime family," calling Joe "lying dead Joe," making statements like "before Joe dropped dead," and there are more. Joe was very confident in who he was and what his purpose in life was, and that was helping others. So Joe was never bothered by what they said about him. He would laugh and say it was a source of entertainment. What bothered him was when they would attack and say untrue things about our San Leon community, its residents, our San Leon MUD District, the other board members, MUD employees, our San Leon Volunteer Fire Department, its members, and our local charities that help our residents in need. They make fun of women, minorities, and resort to childish name calling on social media to belittle our residents. Names like cronies, idiots, small minded, illiterate, stupid, morons, and the list goes on. These people that think so little of our community are now candidates running against our current MUD board. Even a new third candidate has resorted to calling us some of those names. When you do that, where is your integrity? If you don't have integrity, you don't have honesty.



The repeated attacks against them and the misinformation that is posted on social media by these candidates puts a strain not only on the board but on all the MUD employees.

The current board members pay water bills and MUD taxes and are full-time residents of San Leon, which means that every decision they make affects them just like it affects us. I support people who care about our community, help our charities, and don't call names or bully. I support our current MUD board.


