





#### GALVESTON COUNTY CITIZEN SHERIFF'S ACADEMY

The Galveston County Citizen Sheriff's Academy is a 37-hour block of instruction designed to give its graduates a working knowledge of the Sheriff's Office structure, function, and role within the community. The academy is a 12-week course with classes to be held on a weekday night from 7:00PM to 10:00PM. The training is conducted at a location that is convenient for the participants.

Any interested citizen who resides or works in Galveston County is encouraged to participate in this EXCITING! and educational program. All participants must be at least 16 years of age and each attendee is allowed to miss 10% of the training. However, if a participant is forced to miss more than 10% of the course then arrangements can be made for them to make up the needed class at the next academy so they may receive their diploma. Deputies, supervisors and personnel with specialized expertise as well as the Criminal District Attorney will provide the instruction.

The course endeavors to increase awareness by "thinking" about the election periforging meaningful partnerships between Members of the Community and Members of Law Enforcement through education. It is their hope that members of this agency will become aware of the current feelings and concerns of our community through the input and interactions of the participants. # HAVE YOU CHECKED YOUR ZIP CODE?

Jimmy JJ Walker did and got \$1200.00 a year added to his Medicare and, let's face it, he probably needed it. I haven't seen him on TV since I was a teenager. You can call the Medicare helpline and it will be DYN-O-MITE!! Are you going to call to eliminate Co-Pays, add money to your Social Security check or to save money and get everything you deserve? The public has been bombarded lately with a slew of celebrity shills peddling supplemental healthcare coverage. They include ancient football star, Joe Namath with his unnaturally large and white teeth flailing his arms weirdly hollering about all the benefits you should be receiving, a cranky and obstinate old woman named Margaret, and panini press salesman George Foreman.

What is a senior citizen to do? The staff at The Seabreeze News have our worries about aging

(stress, wrinkles) but this puts a whole new level of stress about when we get there and what decisions we should make. The Medi-October 15 each year and ends on December 7. That means that typically, the Medicare commercials and mail start right after Labor Day, with phone calls beginning October 1. Under the Medicare guidelines, marketers cannot call or set appointments prior to October 1, but they can definitely get you "thinking" about the election perikers and agents certified to sell Medicare supplements, Medicare Advantage, and Part D plans, that's a lot of people trying to get your business in less than two



months. (And that doesn't include the insurance companies who also want your business.) Medicare Advantage plans are extremely profitable for the insurance carriers – and agents/brokers only have the Annual Election Period to get as many fish in their net as possible for the upcoming year (not including people who age in when they turn 65).

While these commercials of record-breaking length and frequency seem to spew a lot of information, there is much left unsaid and that's the important information you need to make a smart decision. First and foremost to remember, these are commercials by private insurance companies that are trying to sell additional insurance on top of Medicare and some of the "extras" they claim are already built in to a Medicare plan. For instance, they said you can get free preventative screenings. Medicare covers a long list of preventative and screening services. You don't need to enroll in one of these plans to receive these services. They also say, "All these benefits may be available at no additional cost to you." However, at the moment the narrator says this, a line of small type appears on the bottom of the screen. It's only there for a few seconds while the list of benefits continues. The small type reads," Plan premiums, copayments, and coinsurance can apply." Say it ain't so, Joe!

The Seabreeze News cares about our senior community and we encourage everyone to check out and research any one of these help lines through the Better Business Bureau or look them up online, read their reviews, and double check the fine print.



Charles Marshall Jones (Charlie), 87, of San Leon, Texas was called home to our Lord on October 15, 2021.

Charles Jones was born June 25, 1934, in Borger, Texas to Obie Tyman Jones and Elizabeth Mary Jones.

He is survived by sons, Michael Jones, Gary Jones, and Danny Jones, several grandchildren and great- grandchildren.

He was a long-time member of the American Legion Post 291 in San Leon, Texas. He had a passion for fishing, football, singing and playing country music. He loved his children, grandchildren, and great-grandchildren. Funeral services will be held December 5th, 2021, at 1:00 p.m. at the San Leon Cemetery.

#### Harold D. Caldwell, Retired Chief of Police, Houston Police Department, passed away peacefully on Thursday, the 4th of November 2021, at the age of 90.



Chief Caldwell, known to most who had the pleasure to meet him as Harry, is survived by his wife, the love of his life, Joan; his step-children Garland Pinson, Catherine Pinson, and Elizabeth Pinson Vardaman and her husband, Stuart. "Pawpaw" is also survived by his grandchildren, Sloane Romano, Leah Caldwell, Kendall Pinson, and Wrenne, Knox, and Macaslin Vardaman, and his great-granddaughter, Kayla Romano. Harry is predeceased by his beloved son, Harold Dwane Caldwell, Jr. (2009) and his brothers, James and Dale.

Known as a strict disciplinarian, Harry always held himself and his officers to a strict code of accountability for the use of the authority granted them by the citizens of Houston. Harry was known for his innovative approach to police work, including the "Houstonians On Watch" program; this field training officer program, which he adopted from California law enforcement prototypes, emphasized his focus on professional responsibility balanced with empathy. While pursuing his law enforcement career, he taught police administration and behavioral sciences to thousands of Texas law enforcement officers over the years at the University of Houston, South Texas College, and Sam Houston State University in Huntsville - some of the same institutions where Harry had earned his BS and MA degrees. Harry had completed all his academic work for his doctorate degree when he was appointed by Mayor Jim McConn to the office of Chief of Police. Chief Caldwell held one of the first instructor certifications by the Texas Commission on

Law Enforcement Standards and Education.


Chief Caldwell was a published author. His book, Basic Law Enforcement, is used in many Criminal Justice programs. He designed the Houston Police Academy and lobbied for its construction until it became a reality.

Harry was born in Robertson County, near Franklin, Texas. He and three other members of his Franklin High School graduation class joined the United States Marine Corps in August of 1948. Rising to the rank of Staff Sergeant, he was at one time one of the youngest Staff Sergeants in the Corps. He was a part of the close air support group that supported the 1st Marine Division at the battle of Inchon, Korea. Harry became a member of ComPhibGru 1 under Admiral James H. Doyle; this group evacuated the Marines from Hungnam Harbor in North Korea. For a short period, he was assigned, along with 5 other Marines as security detail for General Douglas MacArthur. Sgt. Caldwell had

the distinction of being personally chewed out by General MacArthur for entering his cabin aboard the USS Mt. McKinley without the general's permission. The General's "attention" did not impact Harry's award of a Letter of Commendation medal with Combat V nor his award of the Korean War Campaign ribbon with three battle stars for his work in helping direct close air support during various battles with the Chinese Communist Peoples Army. After the Korean War campaign, Staff Sergeant Caldwell was detailed to MCRD Parris Island, South Carolina. As a drill Instructor, training Marine recruits, Harry provided some "attention" of his own to a multitude of some of our nation's finest soldiers and patriots. After completing his four-year enlistment in August,1952, he was honorably discharged; Harry made application to, and was accepted for, police training in Cadet Class #10, the following year. He served the citizens of Houston as a police officer for 27 years in every rank from patrolman on the City's waterfront to Chief of Police.

After his retirement, Chief Caldwell became a security consultant, working with both defense and plaintiff's at-

torneys as an expert witness involving premise liability litigation. Life began again for him during these years when he married his beloved Joan in 1988 and raised a young family, Garland, Catherine and Elizabeth. The family would like to express their deep appreciation for Letrese Yarbrough with Caring Hands and Houston Hospice for their compassion and support in Harry's final days.



Jasek Chapel of Geo. H. Lewis & Sons, where Houston Police Chaplain Monty Montgomery officiated, and military honors were rendered by the United States Marine Corps Honor Guard. Interment followed, via escorted cortege, to San Leon Cemetery in San Leon, Texas, where he was laid to rest beside his beloved son, Dwane Caldwell.

If you're going to be away for more than three months, you can even arrange with our office to put your account on vacation and you won't be charged the minimum bill, but only be responsible for fire department fees and streetlight fees. If you have any questions about weatherproofing your home or the District's vacation policy, contact our office and we'd be happy to meet with you!





200-400 Grams	Enhanced First Degree	15 – 99 years in prison or life, and a fine not to exceed \$200,000
Over 400 Grams	Enhanced First Degree	20 – 99 years in prison or life, and a fine not to exceed \$500,000


