Fe and assist with other cities in Galveston County as needed.

Another point of being "unincorporated" means you could purchase property and build your dream home amongst a bunch of empty lots, well old Dav the slumlord might just put a trashy RV park to your left and who knows what's going to be built to your right, it might be a shanty for a single mom and five kids. Those five kids just received a bike from the volunteer fire department for Christmas, and they are in the street and riding through the front of your yard that's not fenced in, with their unleashed dog. Your dogs are in the fenced backyard going crazy because of the noises they are not used to. Nope you can't call the cops on that either.

#### 50 Years in Prison for Repeat **Drunk Driver**

GALVESTON -



Keith Aaron Brazier pled guilty to two charges of murder and one charge of intoxicated assault and was sentenced to a term of 50 years in prison for last year's drunk driving crash in Galveston that killed two teenagers and severely injured a third.

**Keith Aaron Brazier** 

On September 2, 2022, Brazier was speeding and driving while intoxicated when he ran a red light and struck a Jeep that was carrying four Ball High School students at 41st and Ave. O on Galveston Island. One of the students was killed on the scene, and another died in the following days while at University of Texas Medical Branch. A third student suffered severe head trauma but survived the crash.

Brazier had been released from prison that same day at 10:30 a.m. for a conviction of driving while intoxicated - third offense, less than eight hours before the crash. Brazier returned to Galveston County that morning. A witness who was in Brazier's vehicle at the time of the crash told police that he and Brazier had visited multiple bars on Galveston Island throughout the day. Brazier was removed from the bar Sharky's by management approximately an hour before the crash.

Galveston Police obtained a search warrant for Brazier's blood after the crash, and later test results showed Brazier to have a blood-alcohol content of 0.217, well over double the legal limit of 0.08.

At the time of plea, parents of the two murder victims gave victim impact testimony to the Court. The family had approved of the plea for 50 years, and attempted to describe to the Court how the loss of their sons has affected the family and community.





## LETTERS TO THE EDITOR



#### Dear Editor,

January will mark six years that I've been the District Manager for San Leon MUD.

During that time, we've been through some pretty significant changes:

- An expansion at our wastewater plant that will ensure proper treatment and disinfection for existing and future residents
- A resiliency project at the water tower relocating our motor control center and SCADA equipment into the tower and out of the floodplain
- An exponential increase in new development interest, up from only a handful of new tap requests per month back in 2018 to more than 60 requests for new service in recent months
- We've returned the District to fiscal solvency, slowly but surely addressing a history of budget deficit
- We've seen the District's tax rates drop from \$0.63 per \$100 valuation back in 2019 down to only \$0.471 per \$100 valuation for 2023
- We've procured nearly \$15 million in low-interest, no-interest, and grant funds through the Texas Water Development Board to shore up our aging

infrastructure, at the same time refinancing much of our outstanding bonds to take advantage of the historically low market rates

These successes have been great for the community and could not have happened but for the excellent team of staff and consultants that the District has worked with these past few years. While these successes have set San Leon on a trajectory for continued growth, the time has come for me to move into another role with a different organization. I have truly cherished the time I've spent here in San Leon and fully expected that I would retire from here many years from now, but an excellent opportunity arose that will prove beneficial for my family. I know I leave San Leon in capable hands, with a Board of Directors who truly care and a competent staff that will keep San Leon MUD headed in the right direction for years to come.






The San Leon Yard Birds are a very small volunteer group who mow grass for the low income elderly, disabled veterans and those with disabilities.

# San Leon MUD Update

#### What is a sewer cleanout?

A sewer cleanout is a PVC pipe and cap, typically 4" in diameter, that intersects with the sewer line that runs from your home to the District's main lines. It provides an access point for plumbers to diagnose and repair backups in the line that connects to the District's main line. It should be kept closed to function properly, as being left open will result in rain water getting into the District's collection system and inundating the wastewater treatment plant with unnecessary flow. If you have any questions about the location of your cleanout or how to replace a damaged cap, just call the office!
