### District Manager Andrew Miller Earns Certified Public Works Professional-Management Designation

District Manager Andrew Miller has earned the Certified Public Works Professional – Management (CPWP-M) designation from the American Public Works Association (APWA). The CPWP-M designation is to recognize individuals in the public works field who have the knowledge and experience to effectively manage departments within a public works agency.

Andrew Miller began working in the water and wastewater industry shortly after graduating from Houston Baptist University in 2011 with a double bachelor's degree in Business Administration and Sociology. Beginning his industry journey as a dedicated field operator for several utility districts, he transitioned into facility operations and then was quickly promoted into management, handling the supervision of nearly a dozen utility districts across the greater Houston area. In 2018, he began working for San Leon Municipal Utility District as District Manager after a multi-month interview process alongside several other candidates. During his time at San Leon MUD, he has addressed historical deficits in the District's \$5 million annual budget, returning to fiscal responsibility while accommodating unprecedented growth, supervised the \$10 million expansion project of the District's wastewater treatment facility, ensured compliance with regulatory changes such as AWIA 2018 and SB 3, as well as managed several applications for state and federal grants for infrastructure improvement.

To obtain the CPWP-M designation, candidates must have three years of public works supervisory experience and prove their ability to manage a public works department. Candidates must prove competence in the areas of communication, budget and finance, human resource management, administrative operations, procurement and contract administration, project management, asset management, and emergency management, all while displaying an overall understanding of basic public works operations. The Certified Public Works Professional program was launched by APWA in August 2018. ## SPECIAL DEAR STEVE EDITION

Each year, The Seabreeze News dedicates its May Issue to Steve Hoyland, Sr, (Dear Steve). Steve is the founder of this paper and could tell a story like no one else. 



What is a house shut off valve?

A house shut off valve (pictured below) is a valve that's typically found on the side of your home where the water line comes in. While not all homes have a house shut off valve, it's a very important valve if you do have one: if closed, this valve will turn off all water service to the home! While this is handy to take care of any repairs you may need to address inside the home, during the summertime many people accidentally turn the house shut off valve when trying to turn off hoses or sprinklers. If you're experiencing a loss of service, always be sure to check your house shut off valve because it might be the culprit!
