### SAN LEON CONNECTION TO COVID VACCINE

Dallas residents Rose Ann (Janner) Giles, formerly of San Leon, and her husband Kevin Giles are taking part in the Pfizer Pharmaceuticals COVID-19 vaccine trials currently in Phase 3. The couple volunteered for the vaccine trial and received the first dose in late August followed by a second dose approximately 28 days later. They did not know whether they were receiving the vaccine or the placebo. Sometime later, they requested a blood work up and discovered that they, indeed, had antibodies meaning that they had received the vaccine and it was working as designed. They will be tested at six months and then at one year to determine how long the antibodies remain. The vaccine contains genetic material called messenger RNA, or mRNA, which scientists hope provokes the immune system to fight the virus. Pfizer's clinical trial is testing the vaccine in 44,000 people, half of whom will get a placebo. The trial's protocol allows for an initial look at results after at least 32 people in either the placebo or vaccinated group have developed Covid-19. If more than 26 of those people are in the placebo group, then the vaccine is considered likely to be effective. Coronavirus vaccine developers must turn in at least two months of safety data after half of the trial's participants have received the second dose of the vaccine, which Pfizer has said will not happen until at least the third week of November.

There are three areas where success must be demonstrated before seeking approval for public use. The vaccine must be proven effective. It must be proven safe, and Pfizer must demonstrate that they can manufacture the vaccine consistently and at the highest standards. When the criteria has been met, Pfizer will apply for Emergency Authorization Use which would make the vaccine available to the public likely before the end of the year. Under most plans proposed so far, the vaccine would initially be made available to health care providers, first responders and high-risk populations such as the elderly followed by a more broad distribution to the general public at no cost.

## WAITING...

For just the second time in US history, the winning candidate of a presidential election has not been announced on election night. As the Seabreeze News goes to press, neither candidate has reached the required 270 electoral college votes to declare victory. At this time, several states have been determined as "too close to call." The counting of mail-in ballots in some states may take days. The Democratic party was able to hold their majority in the House of Representatives and it appears that the Republican party will still control the Senate.

# San Leon Don's FISHING TIPS

Don is on a first name basis with most of the local fish...



The weather has been very unpredictable and has slowed fishing in our area. Hopefully, by Thanksgiving fishing will move on to the winter season. We have some rule changes by the Texas Parks and Wildlife as follows: November flounder gigging prohibits the daily limit of flounder to (2). This new limit will last until mid-December then return to (5) fish per day. The new legal size limit for flounder is (15) inches. By the time you read this, the flounder run should be on. The Galveston Ship Channel is a good place to fish for flounder. I use soft plastic for bait, Gulp 2-inch white shad. 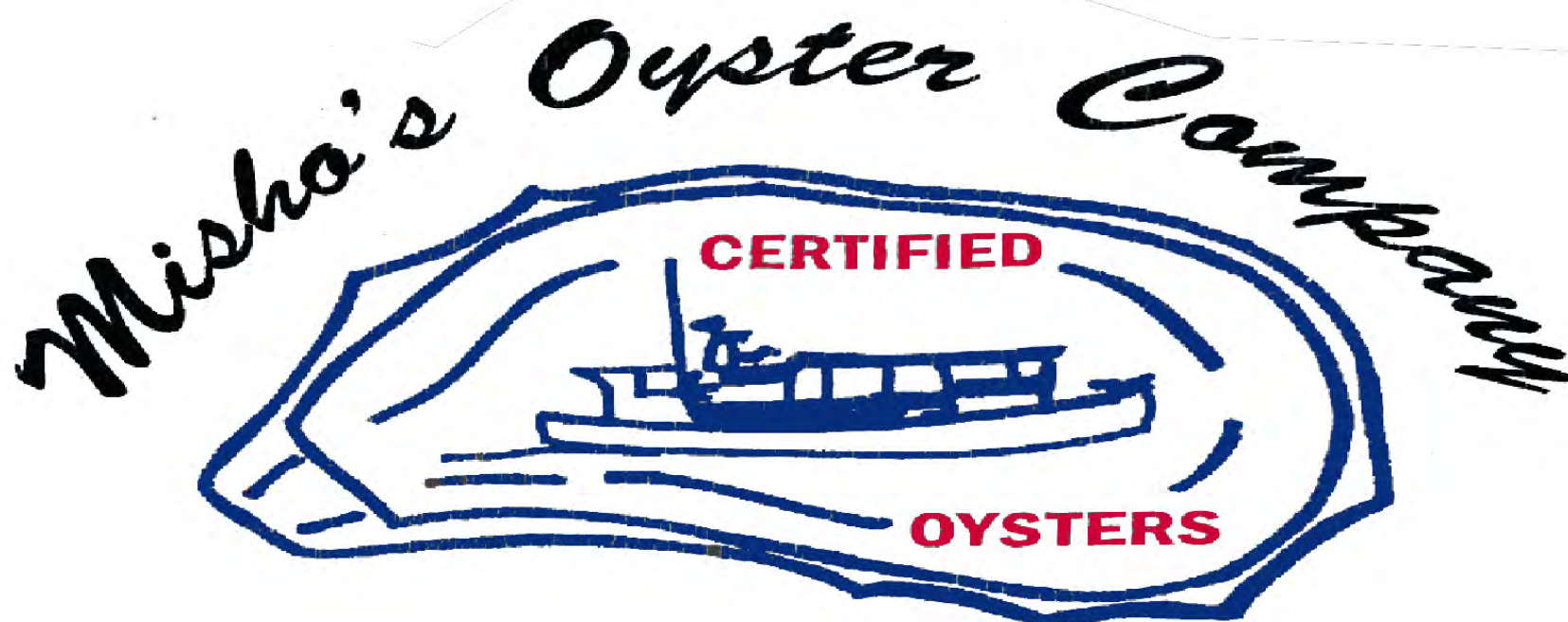

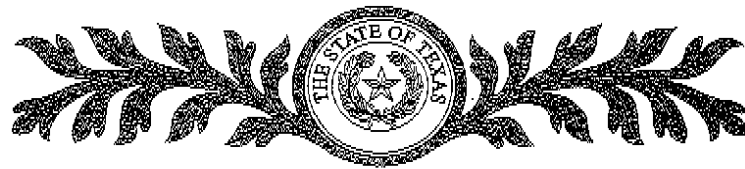


# Steve Hoyland, Sr. Honored by State Rep Mayes Middleton

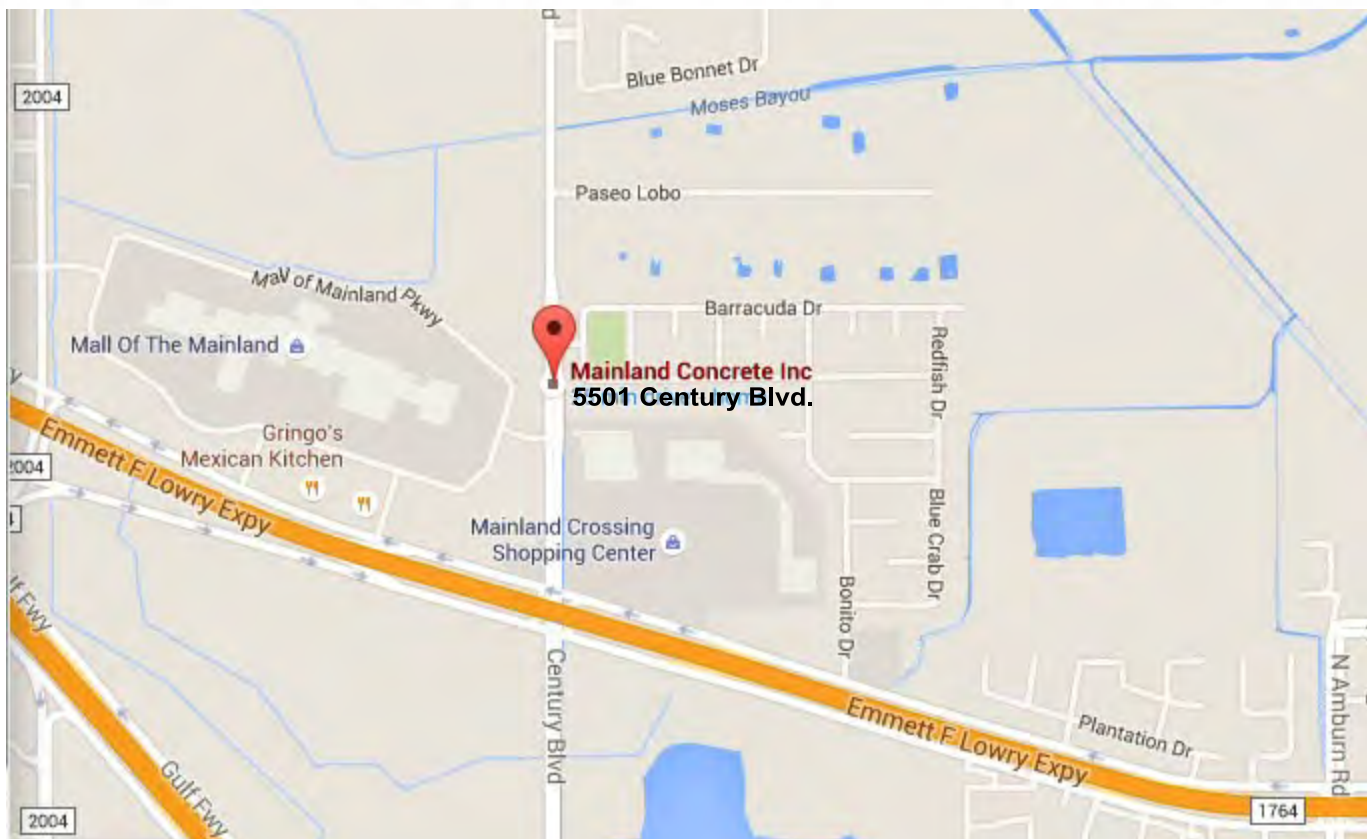

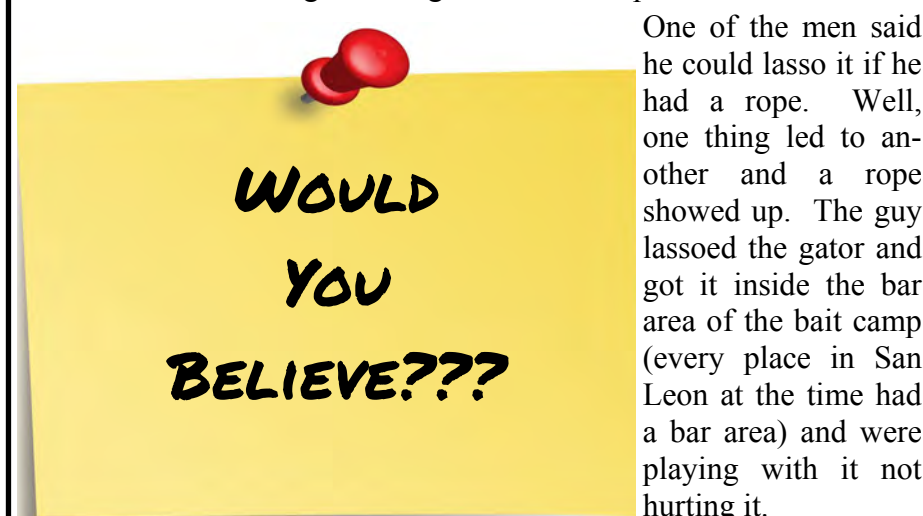
## DICKINSON FESTIVAL OF LIGHTS CANCELLED

In 1976 some guys were drinking beer early in the morning at Kleising's pier (bait camp) when an alligator showed up on the shoreline. It was about 9 feet long and weighed about 300 pounds.



One of the men said he could lasso it if he had a rope. Well, one thing led to another and a rope showed up. The guy lassooed the gator and got it inside the bar area of the bait camp (every place in San Leon at the time had a bar area) and were playing with it not hurting it.

Someone called the Constable. At the time, Jody Pryor was the constable and when he arrived he told those guys it was illegal to have a gator in captivity without a permit. They were told they could be taken to jail, but if they would load the gator and take it to a new location they would be ok and no charges would be filed. It didn't take long for them to decide that's what they wanted to do.

They loaded the gator in the back of a blue pickup and followed Jody to the sand pits, as it was known at the time located on 27th Street. Jody instructed the men where to release it and they backed the pickup close to the water and released the gator.

The Galveston County Sheriff's department rarely came to San Leon in those days as they didn't like our way of doing things. Someone called the Sheriff's department and told them something needed to be done about alligators being put in the sand pits. They said something would be done so the next day in the Galveston Daily News there was an article about the episode. They questioned Constable Pryor and he told them he heard it was four drunks in a blue pickup truck.

End of story.
