

## First Galveston County Criminal Jury Trial During Covid Pandemic Results in 45-year Prison Sentence

GALVESTON – In the first criminal jury trial in Galveston County since Covid pandemic restrictions took effect, the defendant was convicted of aggravated robbery and sentenced to 45 years in prison.

The jury found that Dion Anthony Ruffins used a firearm while robbing Ferry Road Food Store in Galveston. The robbery occurred around 5a.m. on April 12th, 2019. Ruffins entered the store wearing a mask and hat and armed with a gun. Ruffins also wore a black fingerless glove on his right hand. Ruffins worked with an accomplice, Donald Zeigler, who entered the store first and left the door open.

Ruffins, who had three previous felony robbery convictions, robbed the store clerk of between \$500 and \$1,000. The clerk was unable to identify Ruffins due to the robber's mask. Store surveillance video showed Ruffins attempted to rob the store approximately 25 minutes earlier wearing different clothing. Ruffins abandoned the first robbery attempt because the store door shut and locked before he could enter. Ruffins was visible on store surveillance video five minutes later without his mask, wearing different clothing, but wearing the same shoes. A red Lexus was seen on video driven by accomplice Donald Zeigler during the robbery attempts.



A black hoodie and blue hat worn during the first abandoned robbery were located in a backpack on the side of a neighboring apartment complex. The evidence showed that the hoodie contained Ruffins's DNA.

The red Lexus matching the surveillance video was located at the Carlton Courtyard apartments several blocks away. The vehicle was registered to Dion Ruffins, who lived at the apartments. Several days later Galveston Police Department officers executed a search warrant at Ruffins's apartment. Officers found the shoes from the first robbery attempt as well as a single black fingerless glove for a left hand. The State argued that the left handed glove was the match to the right handed glove used in the robbery, which Ruffins disposed of along with the gun used in the robbery.

The trial began September 28. The jury found Ruffins guilty of Aggravated Robbery on September 30 after deliberating approximately 2.5 hours. The case was prosecuted by Chief Assistant Criminal District Attorney Adam Poole and Assistant Criminal District Attorney Raneca Henson. It was the first jury trial conducted in Galveston County since all trials were postponed due to Covid-19.

During the punishment phase of the trial the State showed Ruffins had five prior felony convictions, including three robbery convictions. Prosecutor Adam Poole argued to the jury that they cannot wait for Ruffins to commit another robbery or to potentially kill someone before they give him the maximum punishment. The jury assessed punishment at 45 years in the Texas Department of Criminal Justice. Ruffins will be required to serve fifty percent of his sentence before becoming eligible for parole. At the time of his arrest, Ruffins was also the suspect in two additional robberies in Galveston but has yet to be charged for those crimes.

The Galveston County Criminal District Attorney commends the work of the Galveston Police Department in this case, and the work of the Galveston County District Clerk's Office in providing safety protocols during the trial. Cause No. 19-CR-1235, in the 56th Judicial District Court, Galveston County, Judge Lonnie Cox, presiding.

Don is on a first name basis with most of the local fish...




It's really hard to write anything about fishing with this weather the way it's been. Before these storms, I had a report from Bolivar North Jetty that a few flounder had already showed up.
