If you are voting by mail in the upcoming General Election, your ballot should be sent to you 30-45 days before Election Day or 7 days after receiving your application. Ballots will begin to be sent out September 18th, 2020. You must fill out and return an application in order to be eligible to vote by mail.

Important Dates to be Aware of:

September 18th— Mail in Ballots begin to be mailed.

October 5th—Last day to register to vote in the General Election.

October 13th—In person early voting begins at all polling locations.

November 3—Election Day.

## ABBOTT'S ORDER BRINGS ECONOMIC DISASTER TO LOCAL BAR WORKERS

One of the things that San Leon is well known for are its local bars. These watering holes are more than just places to get a beer or a cocktail. These are the places where friends check up on each other, networking is done for those who need help, news (and gossip) are spread. It is where social interaction happens, often the only interaction some folks get all day or all week. And, yes, places of employment. These are not nightclubs. These are not concert venues. These are not locations where very large gatherings of people occur. In fact, social distancing has been a way of life. On most days there are certainly less than 10 people congregating, having a beer or two and moving on.



Whether you are in favor of bars or a person who doesn't frequent them, the fact is that small local bars were not and are not the sole cause of the COVID spread. When bar owners were asked to shut down, again, after just one month of re-opening, they complied even though they had been given less than four hours' notice. They shuttered their doors and laid off or furloughed their workers hoping that some guidance or information would be forthcoming. It has not. In the over 60 days since the second shut down, Governor Abbott (no relation to Mayor Abbott) has not mentioned anything regarding when and how bars may begin to reopen. So while Governor Abbott ignores the plight of thousands of Americans losing their livelihoods, here are a tiny portion of things he has had time for. GA=Governor Abbott.

## CHECKING IN WITH HILLMAN'S SEAFOOD

The Seabreeze visited with the ladies at Hillman's Seafood this month and had a most entertaining and informative afternoon. Sisters Mary Smith, Sybil Glendye, JoAnn Morris, and Delores McWhorter are the third generation of Hillmans to operate the business. Their grandparents, Anita and Theodor Hillman arrived in the Dickinson Bay area in the late 1920s, partly because Mr. Hillman had heard that the fishing was good there. At one time in the early years, you could find a big pot of shrimp boiling away. Beer was sold, but they gave the shrimp away at no charge. In 1959, Hillman's Restaurant was opened and was the go-to place for a seafood dinner until Hurricane Alicia destroyed it in 1983.

Along with the Hillman family, the Gallo family is a vital part of the seafood market operation. Martin Gallo began working for the Hillman's when he was in his teens. Now is his 80s and retired, his sons David, Eduardo, and Santiago keep the market running and stocked with the best and most beautiful seafood anywhere on the Gulf Coast.

The Seabreeze could fill multiple issues with the tales told and photos shown us by the lovely Hillman sisters. The history of this establishment is long and fascinating. Stop in and see what the catch of the day is, stock up on some fresh Gulf shrimp or whatever you like. And do not forget the cole-slaw, it is famous around here. The best you ever had!

Donations are used for upkeep of the cemetery and are greatly appreciated.

Traveling via golf cart is a way of life in the unincorporated areas of Galveston County, particularly San Leon, Bacliff, and the Bolivar Peninsula. Whether it's running to the store, going down to the beach or bayside to catch a sunset, or just to toodle around town, golf carts are a common way to get around. For years it's been common knowledge that if the carters were to stay off the main highways, (Bayshore Drive, 9<sup>th</sup> Street, and FM 517 in San Leon and Grand Ave. in Bacliff), not drive after dark, and make sure only licensed drivers were operating the carts, that law enforcement pretty much gave them a pass. In the last few weeks that has changed and there has been a major crackdown by the Galveston County Sheriff's Office. As can be expected, most folks were extremely upset and wanted some answers as to why now? It has long been illegal to operate golf carts on the roads of the Bayshore communities. From the Texas Transportation Code Section 551.304, the law reads as follows: Limited Operation: An operator may operate a neighborhood electric vehicle:

- (1) In a master planned community: (A) that has in place a uniform set of restrictive covenants; and (B) for which a county or municipality has approved a plat;
- (2) On a public or private beach; or
- (3) On a public highway for which the posted speed limit is not more than 35 miles per hour, if the neighborhood electric vehicle is operated: (A) during the daytime; and (B) not more than two miles from the location where the neighborhood electric vehicle is usually parked and for transportation to or from a golf course. (b) A person is not required to register a neighborhood electric vehicle operated in compliance with this section. (Added by Acts 2013, 83rd Leg., R.S., Ch. 1135 (H.B. 2741), Sec. 94, eff. September 1, 2013.)

When asked for comment Mayes Middleton, State Representative for this district, said, "I love the San Leon community. We are a community that takes care of each other and frankly wants to be left alone by government. So many rely on golf carts to get around, the parking lot at the Legion or any restaurant will tell you that any day (I have ridden in a number of golf cart parades myself to the VFD, and it's part of how San Leon celebrates holidays and other events). While I of course do not agree with the "re-interpretation" of the law, I will be working with a number of other legislators to change the law to expressly allow golf carts on our unincorporated county roads. Too many freedoms have been taken away lately, so I will fight to make sure people can permanently use their golf cart to get around." The next legislative session in Austin begins in January.

In the meantime, the people of San Leon will continue to utilize the golf carts riding to and from the many new driving ranges and putting greens that have been appearing around town.
