

## SPORTSPLEX U.S.A. OF SANTEE & POWAY - POLICIES AND GUIDELINES

The guidelines and policies of Sportsplex U.S.A – Santee & Poway have been established to protect our customers and to ensure the continuing quality of the facilities. We respectfully request that these policies be adhered to. These rules will be enforced at all times within the complex grounds.

- 1. An entry gate fee of \$5.00 is required for all guests over the age of 17 years old. In exchange, each guest will receive a token worth \$3.00 toward the cost of a beverage in the Sports Pub.
- 2. **No Food or Beverage with the exception of water** may be brought into the complex. Igloos and coolers are allowed with water and ice ONLY. Due to state liquor restrictions, no alcoholic beverages can be brought onto the complex grounds, including the parking lot. A full selection of products is available from the Post Game Pub.
- 3. Consumption of alcoholic beverages, picnics, team parties or tail gating will NOT be allowed in the parking lot. Teams or individuals violating this rule will be asked to leave the facility and take risk of being cited by local authorities.
- 4. Beer and wine are sold at the complex only during legal hours of consumption (daily until 11:00PM), and can be consumed anywhere inside the complex, except dugouts and field of play. Be prepared to show proper ID.
- 5. Smoking is only permitted in the marked "Designated Smoking Area(s)"
- 6. Service animals are the only animals that are welcome at Sportsplex USA. Service animals are limited to dogs that have been individually trained to do work or perform tasks for the benefit of an individual with a disability. Service animals must remain on a leash or in a harness at all times. If, at any time, your service animal's behavior becomes a threat to the safety and well-being of other park guests or animals, based upon Sportsplex USA Management discretion, you will be asked to leave the premises. Emotional support dogs are not classified as "service animals", and therefore are not allowed into the park.
- 7. Motorized vehicles, bikes, skateboards, roller blades and roller skates are also prohibited.
- 8. **SPORTSPLEX USA** is a family-oriented facility, and abusive language, unruly behavior and vandalism will not be tolerated. Violators are subject to immediate ejection from the facilities and could face further suspension from future activities held at SPORTSPLEX USA.
- 9. Batting practice against the fences is prohibited.
- 10. Upon entering the facility, you enter at your own risk. **SPORTSPLEX USA** is not responsible for injuries during play or while on the grounds.
