Minimum permit fee of \$50.00 for any building permit.

A. Planning Board fees:

1. \$350.00 application fee for conditional use permit from Planning Board; due with application
2. Subdivision fees are stated separately in the Subdivision Ordinance
3. Tower fees are stated separately in the Tower Ordinance
4. Junkyard fees are stated separately in the Junkyard Ordinance

B. Appeals Board fees:

1. \$300.00 application fee for Appeals Board: due with application for variances

ANY AFTER THE FACT PERMIT FEE WILL BE CHARGED DOUBLE THE ORIGINAL FEE

Definition: If construction or activity has been started and/or completed without the issuance of a permit prior to beginning, the original fee will be doubled for the after the fact permit unless unforeseen circumstances are determined by the CEO.


