Mt Cutler – Offer to purchase Bagwells: Megan and Erl Brown the realtors that represent Jackie and Dana Bagwell expressed interest in selling to the Town of Hiram 25 acres of property that abuts Mt Cutler. The proposed offer is 25 acres for \$25,000. The Board expressed their interest in buying the property. The Board, the property owners and the realtors all agreed that waiting for the March 6, 2025, Town Meeting would be acceptable. The realtor will write up the purchase and sale agreement stating contingent on a successful town vote the closing will be set for March 19, 2025.

Planning Board Update – Sample Property Maintenance Ordinance: Keisha Garnett and Paul Henniger addressed the Board with questions on the property maintenance ordinance the Planning Board has been working on. Keisha and Skip presented to the Board a sample Property Maintenance Ordinance from the Town of Oxford to review. The Planning Board is looking to use the sample ordinance as reference to create one for the Town of Hiram.
