- 2. Setting up: Exhibitors will be allowed to set up on Thursday, July 10 after 9: oo a.m.
- 3. The exhibitor's space must always be manned by the person responsible or a designee for the exhibition.
- 4. The South Lake County Agricultural Historical Society, Inc. is not responsible for any loss or damage to the person or property of the exhibition or to its employees from fire, act of God or otherwise and is herby released from any and all liabilities of any kind.
- 5. The exhibitor shall abide by all laws of the State of Indiana, County of Lake, and City of Crown Point.
- 6. The South Lake County Agricultural Historical Society, Inc. shall assign the exhibitor space at its discretion within the exhibition areas and the assignment of the Society shall be final.
