
### **GLAMORGAN**



Glamorgan is a large county in South Wales, bounded on the south by the Bristol Channel and to the north by the counties of Carmarthen, Brecon, and Monmouth. There is an extensive belt of industrial activity, centred around Cardiff, Swansea and Neath.

Strangely, the county acquired standards of measure, but not weight, in 1826 and 1835, and seems to have used the sets of weights issued to Cardiff and Swansea (see below). The police force took over inspection in 1859, by which time four complete sets of standards were available. A fifth set was added in 1879 when the Kibbor district was formed. After the Act of 1889 the police continued to operate as inspectors, but they were gradually replaced by qualified civilians.

The boroughs of Cardiff and Swansea obtained sets of standards in 1826, but in 1835 both agreed to loan their sets to the county. This led to a long period of uncertainty, which may account for the rarity of verification marks attributable to these places. The matter was not finally resolved until around 1870 when both boroughs acquired new standards and appointed their own inspectors. The borough of Neath had its own standards in the pre-Imperial period, but it did not acquire proper standards and appoint an inspector until 1889. Merthyr Tydfil became a municipal borough in 1905, and a county borough in 1908 when it also became a Weights and Measures Authority.

The lack of proper arrangements for inspection in Cardiff and Swansea is reflected in the lack of evidence for a specialist trade in scales and weights. Eventually scalemakers from Bristol began to set up in these places: Perry in Swansea by 1869 and Greader in Cardiff by 1876. The booming industrialisation of the late nineteenth century led to an influx of large firms, such as Avery, Bartlett, and Parnall, and many small local firms soon followed.

# WEIGHTS & MEASURES AT DOWLAIS. (To the Editor.)

Sir,—Had your correspondent been conversant in the law relating to weights and measures, he might have saved himself the trouble of writing the paragraph which appeared in your last week's impression, and if he will take the pains to read the 63rd chapter of the act applying thereto, he will find that it is the inspectors duty to attend every market town once a year (or oftener by the discretion of the magistrates) with his imperial standard, and there compare and stamp all weights, &c., that may be "brought to him," and without a public notice how are the tradesmen to know that he is there. He should know also if other inspectors are taking the law into their own hands by paying the shopkeepers an "unexpected" visit, seizing their weights and scales, without first giving them a chance to have them corrected (for every reasonable man must admit that there is a wear and tear to all things) that is no reason for the Merthyr inspector to do the same. If, after a notice given, parties do not bring their weights, &c., to be compared and corrected, it is then (or upon receiving an information from any one) the inspector's duty to pay them the "unexpected" visit your correspondent is not aware that the inspector keeps a book in which he registers the number and weight of all weights, &c., in his district, so that he can easily ascertain whether they bring all their weights or not, and if your correspondent had only waited a few weeks until the inspector finished his rounds, he might have heard by some friend or other, or through your paper, that the inspector had paid an "unexpected" visit to some of his friends at Dowlais.

Traditionally, weights and measures in Cardiff were under the authority of the Court Leet of the Manors of Llystalybont and Rothdogfield, where the Marquis of Bute was Lord of the Manor. This court seems to have continued well into the 19th century, when it was held annually in October. W. Luke Evans (see below) claimed to have served regularly as a juryman.

The office of Public Weighman had been established in 1747, following unease about the lawfulness of the scales and weights then in use [1].

In 1826, a short set of standards was issued to J. Richard and J. Bird, Magistrates. In 1835, the Corporation of Cardiff, along with that of Swansea, loaned the standards to the county, free of charge [CMG: 10/1/35]. This set was completed by the County Treasurer and then entrusted to Mr Watkins, the county inspector for the district. In 1845, it was reported that there had been no inspection in Cardiff itself for some years, and that the weights transferred to the newly-appointed district IWM were defective [CMG: 5/7/45]. Thomas Yorath, the district inspector, then became active within Cardiff, and in 1846 at a Town Council meeting, the Mayor suggested that he carry out inspections without prior notice [CMG: 6/2/46]. The mark illustrated above was probably used at this time. In 1855 [W] and 1858 [Bi] Yorath was listed as a cooper.

The situation changed radically when the Superintendents of Police took over inspection for the county districts. Supt John Thomas was deemed to have no authority within the borough [CMG: 16/2/61], although he was listed as the IWM in 1863 [W]. This state of affairs rumbled on: the Cardiff corporation could only appoint its own IWM if it had its own Quarter Sessions [CMG: 16/2/61], currently the power to appoint /dismiss lay with the County [CMG: 28/9/61]. The Standards Commission report of 1867/8 simply stated that 'inspection in Cardiff had been transferred to the county'. Discussion regarding a Cardiff Local Act was reported in 1870 [CMG: 19/10/70; WM: 22/11/70], which culminated in the Cardiff Improvement Bill [WM: 5/4/71; 5/5/71; 15/8/71], of which one of the key clauses was that the Corporation should be empowered to appoint its own IWM. When this passed into law, the Corporation moved to acquire the necessary beams and scales from Messrs De Grave, Short & Co of London [WM: 26/9/71] and to appoint W. Luke Evans as its IWM [SWDN: 13/2/72]. It seems that Evans was ineffective, but it was only in 1893 that the need for a more active IWM was recognised.

The first qualified inspector was T.C. Major (1893-1927) [MR 23:179; 27:91; 37:71]. In 1899 he initiated a strict regime, prompting a cartoon in the Western Mail (see below) [MR 99:213-4, 220]. He was followed as chief inspector by Henry Eddins (1927-42) [MR 27: 194; 42:95; 55:28], C.S.Barnes (1942-60) [MR 42:95; 60:36], H.F. Lacey (1960-64) [MR 64:187], and O.W. Barnes (1964-74) [MR 64:159].





When Merthyr became a CB in 1908, standards were obtained and the number 623 was issued. A separate police force was established, and the first chief constable was James A. Wilson, previously superintendent of the county division, who had qualified as IWM in 1900/01. He continued as CC and chief inspector of WM until 1920. In 1910 another inspector, I.G. Davies, qualified, was issued with the number 578, and was listed in 1912 but he moved to Pontypool before 1922.

F.H. Jenkins (q 1915) was chief inspector (1922-50) [MR 51:21]. Both numbers were listed in 1928 but only 578 was used by 1939. W.E. Adams succeeded as chief (1950-72-).

There are references to old standards at Neath in the archives of the Neath Antiquarian Society [NAS/GAT 1/1/4], but all references to inspection indicate that it was carried out by the County.

When Neath acquired standards and was issued with the number 481 in 1889, Evan Evans (CC 1888-99) undertook the role of IWM, being listed as such in 1892 and 1896 [AR], but he was unqualified. Robert Kilpatrick (CC 1899-1900) was a qualified inspector. Advertisements for a Chief Constable in 1900 stated that the new CC would be required to act as the IWM and if not already qualified, should qualify within six months of appointment [SWDN: 12/11/1900; WM: 11,12/11, 1900]. However, Kilpatrick's immediate successors as chief constable were both unqualified. William Higgins (CC 1907-21) had qualified in 1891/2 in Ireland and is listed as IWM in 1912 [Hbk]. When his successor H. Rawlings (CC 1921-26) failed to qualify, the Swansea inspector Jehu Bingham was appointed from 1922-25. [MR 25:127]. From 1926 to 1939 the post of inspector was held by E.M. Abraham, the county inspector for the Port Talbot district of Glamorgan. In 1927, the Glamorgan Local Government Board acquired the Neath standards, the cost of overhauling them being borne by the Borough [MR 1927: 93].

In 1939 the borough decided to set up its own WM service, and W.O. Bowen was appointed as IWM. He served until 1963 [MR 63:148].

**Rhondda**. This town was part of the Ton Pentre district of the county. It became a municipal borough in 1955, and a WMA in 1965 [MR 66:79].

In 1826 standards [152] were issued to the clerk of the market, L. Thomas. In 1835, the corporation of Swansea allowed its complete set of standards to be used by the county, free of charge [CMG: 10/1/35]. A year later, when 'Mr Harrison' retired as the IWM, the county appointed Richard Evans, subject to the approval of the Swansea magistrates [CMG: 9/4/36]. In 1845, the standards were still in use by the county, but the corporation decided that they should only be used within the borough [CMG: 5/7/45]. In 1850 and 1853, there were complaints that the Glamorgan inspector was effectively acting only as the IWM for Swansea, not travelling outside the borough [CMG: 5/1/50, 25/6/53, 6/10/54]. However, in 1860, the problem was that the borough had appointed its own IWM, although it was argued that the borough was subsumed in the county district [CMG: 7/1/60]. The borough continued to claim its exemption from inspection by the county police force [CMG: 7/4/60]. In 1865 [We], Richard Lewis was listed as IWM and again in 1868 [S]. It was officially recorded in 1866 that a whitesmith was acting as inspector.

New standards [1431] were issued in 1869, and John Allison (CC 1865-77) is first cited as IWM in that year [WM: 5/6/69] and is listed as IWM in 1871 [K] and 1875 [Wo], continuing in post until his death [WM: 2/1/78]. Inspector George Holland was appointed IWM on a full-time basis, and raised to the grade of Superintendent [WM: 2/10/78], resigning in 1891 [WM: 3/4/91], with superannuation at the level of a Superintendent of Police.

The first qualified inspector was Jehu Bingham (q1890/1-36). He was followed by W.H. Hiscocks (chief 1936-46) [MR 47:3, 30] and F.W. Brown (chief 1947-74) [MR 47:63, 79:108].

Thomas Henry Greader, b<1854> in Bristol, established his scale-making business in 1876. William Kirk was listed as a scalemaker at the Caroline St address in 1880 [S] but the company was cited as Kirk and Greader the same year [B]; the listing then reverted to Greader in 1882.

However, in 1901, the company appeared as Greader & Howell (Late T.H. Greader); the accompanying advertisement includes the information that Greader was then acting as the South Wales Agency for Parnall & Sons, although Parnall had a presence in Swansea then. Parallel to this, the listing also remains as T.H. Greader.

The firm then changed its name to Greader & Son, working from the same address initially.


