
LANCASHIRE




Lancashire is a large county in the north-west of England, bordered by the sea to the west. The counties of Cumberland and Westmorland lie to the north, the West Riding of Yorkshire to the east, and Cheshire to the south.

In the nineteenth century the county was transformed. It began as a mainly agricultural region but became an area with many large urban regions and a variety of industrial occupations. This transformation led to frequent changes in the administrative structure, both in the county-at-large and in the towns and cities.

Because of the complex and changing structure, the information about weights and scales is presented here in six sections. The sections correspond geographically to the six ancient hundreds of the county, as shown in the map above. (The hundred of Lonsdale was divided naturally into two parts, North and South 'of the Sands', but it was administered as one unit.) It must be stressed that, although the administration of the county was based on these geographical areas, the individual hundreds did not have independent jurisdiction.

In 1826 the county appointed six inspectors, one of whom covered the hundred of Amounderness and probably other parts of the county. After the legislation of 1834 the hundred had its own inspector. The county police force was set up in 1840, and it was agreed that the police would take over the inspection of weights and measures as vacancies occurred. Thus it was that in 1844 the first police officer to act in this way in Lancashire was appointed for Amounderness.

In 1856 the hundred was split into two districts, based at Garstang and Kirkham, and this arrangement continued for many years, with the numbers 91 and 92 being allocated in 1879.

The ancient borough of Preston was the dominant town in the region, and acquired the new Imperial Standards in 1826. At that time the regulation of weights and measures was in the hands of the Court Leet. In 1835 a full-time inspector was appointed and thenceforth inspection and verification were carried out in the usual way. In the second half of the nineteenth century Blackpool became a large and prosperous holiday resort. It was established as a Municipal Borough in 1875, but did not acquire standards until 1889.

The trade in scales and weights was mainly based in Preston, where the firm of Wilcock and Sons was prominent around the turn of the century.

HAT the Justices of the Peace, assembled at the General Quarter Sessions of the Peace, holden at Preston, in and for the County Palatine of Lancaster, on the 5th day of January inst., ordered and directed that JOSEPH MYERS, of Preston aforesaid, Gentleman, the Inspector of Weights and Measures, within the Hundred of Amounderness, in the said County, abould attend for the purpose of Comparing and Stamping the several weights and measures to be used within the said Hundred, at the several piaces and times following,

At the Town of Preston, on the first Saturday in each ralen-

At the Town of Garstung, on the second Thursday in the

months of February, May, August and November.

At the Village or Town of Poulton, on the first Monday in the months of February, May, August, and November. At the Village or Town of Kirkham, on the first Thursday in the Munths of February, May, August and November.

And I do hereby give further Natice,

Inspector of Weights and Measures for the Hundred of Amounderness.

Shopkeepers and others are orgently recommended to avail themselves of the above opportunities without delay, the Justices having determined that after the expiration of a reasonable tine, from this Notice, the High Constable of the Hundred shall go round to examine all Weights and Moasures, when such as are found deficient will be forfeited, and the Owners punished according to Law.

For general convenience, incorrect weights may be rectified at the several Places and Times above-mentioned.

The seaside resort of Blackpool was originally a small part of the parish of Bispham in Amounderness hundred. Although the Blackpool Improvement Act of 1856 had included the appointment of an Inpsector, the borough only acquired standards in 1889. A mark comprising a quartered shield surmounted by a seagull has been recorded as being used briefly on measures 1889-91. The number 553 was issued in 1891.

Despite being unqualified, John C. Derham (CC 1887-1911) served as the IWM until his death in 1911 [MR 11: 400]. His successor W.J. Pringle (CC 1912-19) had qualified in 1897/8 in Northumberland, and also served as IWM. The next chief constable Herbert E. Derham (CC 1919-35) was unqualified, but he was listed as the chief inspector in 1922 [Hbk], assisted by a qualified inspector R. Saxon (q1915/20). In 1925 a civilian chief inspector, W.A. Ladds, was appointed. He served until 1959, when he was succeeded by N.K. Whitehead [MR 59:4, 59:116, 74: 51; 79:39].



In 1832, the Preston Court Leet stated that its primary purpose was to examine the weights and measures of the town [PC 5/5/32]. The following year, the Court Leet Jury maintained that it was not prepared to continue in this role, when no penalty was levied on those owning deficient weights [PC 29/6/33] and again, in 1834, a letter published in the Preston Chronicle highlighted the invidious position of the members of the Court Leet Jury and emphasized the need for the proper, regulated examination of weights and measures [PC 3/5/34].

In November 1834 Joseph Myers, the county inspector for Amounderness hundred, was appointed as the inspector for Preston, although this is only mentioned specifically in an advertisement of 1835. In 1841, Thomas Pollett, a police officer, was cited as the borough inspector [PS] and, by the following year, this role had been assumed by Henry Rigby, a police inspector, [PC 26/2/42]. When John Brodbelt retired as the Market Looker in 1846, Rigby undertook this role too [PC 16/5/46]. In 1853, Rigby was relieved of his role as Inspector of Police but continued his work as Market Looker, with responsibility for WM [PC 17/12/53]. By 1876, Henry Rigby was unfit to work full time so that Daniel Wilson was appointed in his stead [PC 16/9/76]. Wilson continued in charge of weights and measures until his death in 1888 [PH 14/1/88; MR 17: 170].

For a period in the 1870s and 1880s it seems that the mark was changed yearly, the figures indicating the date, not a verification number [AR 1882]. A mark with the 'lamb and flag' device of the borough and VR 83 is illustrated below, amongst others.

John Preston Robinson was appointed IWM and market superintendent in Wilson's stead [PH 18/2/88] and remained in post until his death in 1917 [PH 24/3/17], although unqualified. The first qualified inspector was his son, W.B. Robinson, (q1904/5 in Preston), appointed on the death of his father, and he retired in 1945 [MR 05: 152; 45:111]. He was succeeded by Ralph R. Tutte, who had moved to Preston, from Blackburn and Accrington, in 1924; he was chief 1945-51 [MR 51:232; 56:108]. He was followed by G.S. Heald, 1951-72 [MR 72:239].

¶ Before the passing of the 1834 Weights and Measures Act, Preston had moved to regulate its weights and measures, as evidenced by the first advertisement from the Preston Chronicle; the second one, from the same source, records Joseph Myers' acting as the Inspector of Weights and Measures after the passing of that Act.






