
NORFOLK



Norfolk is the largest county in the region known as East Anglia. It is bordered to the south by Suffolk, to the west by Cambridgeshire, and to the north and east by the sea. In medieval times East Anglia was a major centre of trade, based on the agricultural produce of the region, especially wool. Lead weights stamped with the Norwich arms of a castle and lion, dating from Tudor times onwards, are found regularly throughout East Anglia.

After 1834 the arrangements for inspecting and adjusting weights by the county authorities were complicated and irregular, a situation which continued after the police took over in 1856. The ancient boroughs of Norwich, Kings Lynn, Great Yarmouth and Thetford were separately responsible for weights and measures, and a few other localities also claimed separate jurisdiction in the 19th century.

Few records of scale makers in Norfolk before the 1840s have been found, but they must have existed, particularly in Norwich. From around 1845 onwards the Stanley family, possibly related to London scale makers of the same name, were working in Norwich. The Stanley business was taken over by W.H. West in 1883, and eventually became part of the Avery empire in the 1960s. Several other firms were set up in East Anglia, but most of them suffered the same fate.

On the left is a bronze weight with, at the top, the Norfolk county mark from the time of William IV. Also visible are several other marks. There is a later county mark for the Norwich district, and the initials T W S, probably indicating Thomas W Stephenson, one of the 1834 'inspectors'.. There are also two Norwich marks.

On the right is another bronze weight, made in London after 1826. In the centre is the mark for the Norfolk district of Walsingham, and there are also the letters X, Y, Z, believed to be the marks of an adjuster.

WHEREAS persons are going about several parts of the County of Nurfolk with Impreper Weights and Measures, pretending to benutherised to compare and adjust those belonging to Tradespeople for the sake of gain, whereby grant injury and risk are incurred, imasmuch as even correct Weights and Measures are frequently rendered defective through such practice:—

Notice is hereby given, that no other persons than us the undersigned are authorised to examine, compare, and stamp such Weights and Measures within the said County, (the City of Norwich and Bossughs excepted) and all Weights and Measures not examined, compared, and stamped in conformity with the directions of the Acts of Parliament, will be seized, and the persons in whose custody may be found will be proceeded against. Dated fifth day of September, 1841.

Norwich was at one time the second ranking city in England. The city badge of a castle and lion {1} is found stamped on lead weights from Elizabethan times onwards, and it was still used on bronze and brass weights in the 19th century {2}. Before 1834 WM was under the control of a Leet Jury of four persons appointed annually by the Mayor, who presumably used the standards [296] issued in 1826. In 1835 a regular inspector, James Grinling, tea dealer, was appointed.

In 1838 it was reported that both Grinling and the standards had disappeared. The matter was complicated by party political disputes, and disagreements between the Recorder and the Council. (*Norfolk Chronicle*, 27 October 1838). A new set of standards [863] was obtained, and a new inspector, James Kemp appointed. He was listed as the inspector in 1839 [P] and 1842 [B]. In 1843 he was succeeded by James Chamberlain (*Norfolk Chronicle*, 20 May 1843), who continued at least until 1854 [W]. Various marks {2,3,4} seem to have been used at this time, some possibly for the weights belonging to county tradesmen who regularly visited the Norwich markets.

By 1865 Thomas Cousins was chief inspector and, he had an assistant, Samuel Sutton. Cousins died in 1866 and Sutton became the chief, with Joshua Holmes as his assistant. [N/TC 28/11]. F.W. Markham was appointed in 1886, and Holmes was made chief in 1887 [N/TC 57/7]. Holmes and Markham were the inspectors listed in 1892 and 1896 [AR]. The number 112 was issued in 1879 {5,6}.

Edwin F. Winch, who had qualified as IWM in 1891/2, was appointed as chief constable in 1897 and responsibility was transferred to his department in 1898. Two police officers, Jacob Southgate and William Thompson, qualified in 1907 and they served until c1923. After Winch retired in 1917 the inspectors remained in the police department, E.C. Buttle serving from 1923 onwards, and E.E. Scott from 1934. When Buttle retired in 1947 the WM office was transferred to the Health Committee [MR 47:112]. Scott became Chief Inspector and continued to serve until 1973, when authority passed to Norfolk County Council [MR 74:94].

By the start of the nineteenth century the town council had established itself as 'Lords of the Manor' and there was a Court Leet for WM business. In 1834, Thomas V. Wright, serjeant-at-mace, was appointed as inspector. He was also listed in 1854 [W], but in 1864 [W] the inspector was Samuel Linay and in 1868 [H] it was Mathew Smith. Apparently inspection became the responsibility of the police soon after this, and George Ware (CC 1866-98) was listed as IWM in 1892 and 1896 [AR].

The first qualified inspector was Walter Payne (CC 1898-1913, q1895/6). Charles Hunt (CC 1913-23) was not a qualified IWM, but Henry Young (CC 1923-45) had qualified before 1920. During WW2 a temporary arrangement with the county was made, and in 1948 it was made permanent [MR 48:39]. The borough was formally disqualified as a WMA in 1965.

In 1826 standards [115] were obtained for the use of the head constable, John Whistler, who had acted as inspector of WM since about 1814. In 1834/5 William Bond, gunmaker, was appointed. He was still listed in 1839 [P]. Later the borough employed a county police officer as the official inspector, but Edward Bond, a descendant of William Bond, was described as an 'inspector' in 1868 and 1877 [H] (see below).

The police inspector in 1869 [K] was Edward Jones, who was based in East Harling. In 1877 he was succeeded by Robert Starke, who continued until 1889, when the borough was disqualified as a WMA and responsibility passed to the county. In 1892 the standard weights were handed over to the firm of Bond [T/WM 1/1].

The standards were rediscovered in 1929 in a loft [2, 3], see also the *Eastern Daily Press* 27/9/1929. They were made by Doyle of London. These standards are now in the Thetford Museum, which also has some stamping equipment with the VR242 mark [ref: T 1975.235-237].

The inspector appointed in 1834 was Peter Coble, who had previously held the post under the Acts of 1795/7. William Pratt is also mentioned as having been appointed under the Act of 1815.

Subsequently the post was held by J.B. Beales (1857-), E.D. Louttid (1860-1871), and F.W. Robinson (1871-74). In 1874 R.J. Buddery was appointed, and he was still in post in 1912. It is recorded that H.M. Buddery passed the qualifying examination and was appointed in 1915. Reginald Hammond qualified in 1921 and retired in 1938. He was succeeded by G.C. Davies, who continued until authority passed to Norfolk CC in 1974 [MR 74:71].

Diss The parish of Diss acquired standards [116] in 1826 and another set [595] in 1835. Both sets were issued to the parish constable, William Dixon. In 1856 [C] Samuel Cobb, a plumber and glazier, was listed as IWM. It is recorded [PD/100/338] that in 1877 a set of standards from Diss was sold to **Josiah Fisher**, who was at that time an adjuster in Barnham Broom.

New Buckenham was a 'seigneurial borough' founded in the 12th century. By the 19th century it was in the hands of a Lord of the Manor and his Court Leet. Standards [210] were obtained in 1826, issued to J. Gall, bailiff. It was reported that a leather cutter was acting as inspector in 1866. The standards were reverified in 1878, probably when a local solicitor, A. T. Clowes, became Lord of the Manor, and wished to assert the manorial rights. The mark shown was listed in 1882 [AR], and in 1883 [W] Edward Palmer, a grocer, was listed as the IWM.

The New Buckenham standards were eventually sold. Some of them are illustrated in the article [3] published in 1934, when it was said that they were kept in Banham, possibly by the firm of **Josiah Fisher**.

North Walsham A set of standards [224] was verified for the parish in 1826 and reverified in 1854. Inspection was transferred to the county before 1867. See also [3].




