We are not a funeral home, do not embalm, arrange funerals or burials, and do not sell pre-need cremations or funerals. We do offer direct cremation at affordable prices.

Item	Price	Description
Professional Services	\$650.00	24-Hour availability to respond to your request for services; Conference with family regarding direct cremation; Preparation and delivery of original death certificate to doctor; Obtaining cremation approval from County Medical Examiner; Filing of original death certificate with appropriate Office of Vital Statistics; Notification of death to the Social Security Administration via Electronic Death Registration System; Returning of cremated remains to next of kin or designee. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance, utility expenses, administrative costs, equipment and inventory expenses, local, State and Federal government compliance. This fee for our basic services and overhead will be added to the total cost of the direct cremation services you select.

Alternative Cremation Container	\$50.00	Caskets are not required for direct cremation, although a container to encase the body is required by law. You, the purchaser, have the option of providing an alternative cremation container and deleting this price from our regular fee.
Removal and Transportation to Crematory	\$300.00*	Includes removal of the deceased from place of death and transportation to the crematory from the following Florida Counties: Orange; Seminole; and Osceola. <i>* Additional fees may apply for extraordinary removal situations and/or infectious disease.</i>
*Extraordinary Transportation	\$200.00-unlimited	Difficult removals due to size or location, removal from a home, unnecessary delay, infectious disease or outside of service area MAY incur additional transportation fees. Service area includes all of Orange, Seminole and Osceola counties.
Refrigeration and Cremation	\$450.00**	Florida law requires the deceased to be embalmed and/or refrigerated within twenty-four hours. Embalming is NOT required for direct cremation. <i>** Additional fees may apply for extraordinary refrigeration time. Also, may apply due to size/weight.</i>
**Extraordinary Refrigeration	\$75.00 per day	Cremation may not occur within 48 hours of death. Physicians and multiple agencies are involved in the certification process required prior to cremation. Refrigeration longer than three weeks MAY incur additional fees.
**Extraordinary Cremation	\$300.00-unlimited	These additional cremation charges are based upon the ability of standard equipment to service the deceased (weight or size). Therefore, alternative cremation options must be used.
Rigid Container (temporary urn box)	\$25.00	To hold the cremated remains.
Pacemaker	\$125.00	Removal and disposal of pacemaker prior to cremation.
Infectious Disease	\$50.00	When extra personal protective equipment is needed to transport decedent.
Transfer of Deceased Prior to Opening Electronic Death Registration	\$200.00	Fee for removal and storage of deceased prior to electronic initiation of death certificate.
Transfer of Deceased After Opening Electronic Death Registration	\$350.00	Fee for removal and storage of deceased after electronic initiation of death certificate.
TOTAL itemized price for Direct Cremation	\$1,475.00	Includes Professional Services Fee, Transportation, Alternative Container, Refrigeration, Cremation, and Rigid Container.

Urns	\$65.00-unlimited <i>Keepsake urns starting at \$40.00</i>	Cremated remains will be returned in a rigid container. Purchasing a permanent urn is recommended but never required. <i>Urn vaults and biodegradable urns are also available.</i>
Local Delivery	\$100.00 - \$200.00	We can hand deliver your cremated remains and death certificates for \$100.00 within a 5-mile radius of our office. All other deliveries within our service area will be \$200.00.
Certified Death Certificates	\$125.00	This is a courier/handling fee per order over and above the County fees if not procured at the time of initial service.
U.S. Veteran's Flag	\$125.00	This is a courier/handling fee. Must provide DD214 paperwork.
Domestic Shipping	\$225.00	This includes a courier/handling fee and the USPS fees. Cremated remains are sent via USPS Priority Express only.
Memorial Items	Market Pricing	Memorial books, jewelry, photo frames, art glass, personalized items, etc.
Portions	\$10.00	Small portions of cremated remains removed and provided to family.
Consultation	\$200.00 per hour	Because a third party can be helpful when making some decisions, this fee applies only if you would like a direct cremation specialist to consult regarding your pre-planning needs. We do NOT sell pre-need arrangements nor sell or arrange traditional funerals and burials.
Death Certificate Amendment – Simple	\$300.00	After Death Certificate has been certified the family provides proper documentation and requests a change to the Death Certificate.
Death Certificate Amendment – Storage	\$400.00	When a deceased has been left with the medical examiner's office for more than 10 days, the office has to certify a Death Certificate as a Storage case. Family must provide information and documentation for almost every field on the Death Certificate.

Amaryllis Cremation LLC recognizes the hardship families experience with the death of a child. Therefore, our pricing for losing a child is \$500.00 for miscarriages and still births; \$700.00 for children birth through 12 years of age; \$900.00 for children 12 – 18 years of age.

Package A	\$1,245.00	Includes removal of deceased within the service area; refrigeration; death certificate preparation and filing; cremation; alternative cremation container; return of cremated remains in choice of selected urn or scattering tube; payment of Medical Examiner's fee; up to ten (10) Certified Death Certificates.
Package B Biodegradable	\$1,445.00	Includes all of Package A with your choice of selected biodegradable urn appropriate for earth or water burial.
Package C	\$1,625.00	Includes all of Package A. Also includes an upgraded selected urn choice; Ten (10) additional certified death certificates (total of twenty); no handling fee for removal and disposal of pacemaker, or for veteran's US Flag when family provides DD214.

Payment Options:

Amaryllis Cremation LLC accepts cash, checks, and credit cards. It is the practice of our business NOT to file against an Estate for payment due. We do not accept insurance as payment. Fees must be settled in advance of final disposition (cremation). Financing is not available.

The Federal Trade Commission requires the disclosure of costs of each individual funeral item and service offered. You are entitled to complete information via telephone, mail, or personal inquiry. Under these regulations, those who offer Direct Cremation must tell you that Florida State Law does not require embalming, or the use of a casket for direct cremations.
