Information

- 1. THERE IS NOT A RAIN DATE FOR THIS EVENT. Should the festival be cancelled or shortened due to inclement weather, hazardous conditions, and/or other vendor fees will not be returned. Other marketing opportunities will be provided. Vendor registration is non-transferrable.
- 2. Family Lyfe A Nonprofit Organization, Jersey Lyfe, Southern New Jersey LGBTQA Pride Committee 2019, and/or its affiliates will not be responsible for any loss or damage to merchandise or displays.
- 3. Vendors are responsible for bringing their own table, chair(s), and tent. If you need to table and/or chair(s) there is a \$20 non-refundable fee required which covers one 8' table and two chairs. Orders must be placed at least 30-days prior to September 8, 2019.
- 4. The fee for a for-profit and non-profit/outreach or organizations is \$20.00. This fee is non-refundable.
- 5. Tents larger than 10x10 must be approved before the festival. Tents 10x10 or smaller are pre-approved.
- 6. The sale of merchandise containing the official Jersey Lyfe logo or any Southern New Jersey LGBTQA Pride paraphernalia is prohibited.
- 7. Vendor and security volunteers will be available throughout the festival to answer questions or help with emergencies.
- 8. All trash must be removed from the premises. Please place all trash in the proper receptacles provided. Vendors who fail to remove trash will be charged a \$30 fee.

- Vendors must check-in with the vendor coordinator at the entrance to the festival (location to be advised). The vendor check-in will be open at 10:00 a.m. The festival site is open to the public at 12:00 p.m. Unloading of vehicles must be completed and vehicles removed from the festival site by 11:30 a.m. failure to clear the festival grounds of all non-authorized vehicles will result in the forfeiture of your placement and no refund will be permitted.
- 2. There will be music and entertainment all day. Radios, megaphones, and loudspeakers may not be allowed. Participants MUST confirm usage with the vendor coordinator.
- 3. Food vendors must meet all health and sanitary codes and be in compliance with all local, state, and federal regulations in regards to the handling and serving of food. SECONDLY, any food vendor using propane gas, must have an inspection of your unit will be performed at the Camden County Fire Marshall's Office and fees paid before the event.

STEP ONE:

PLEASE REQUEST A COPY OF the Camden County Parks Department permit application and guide for vendors. REGISTRATION IS NOT COMPLETE UNTIL REQUIRED PERMIT(S) have been satisfied. Failure to comply with event and city regulations will result in cancellation of agreement without refund or exchange. This step applies to all food vendors.

STEP TWO:

This step may not apply to all food vendors – only vendors using propane gas. PLEASE REQUEST A COPY OF THE CHERRY HILL FIRE DEPARTMENT REQUIRED permit application and guide for vendors. REGISTRATION IS NOT COMPLETE UNTIL REQUIRED PERMIT(S) have been satisfied. Failure to comply with event and city regulations will result in cancellation of agreement without refund or exchange.

Anyone not using propane say like an ice cream vendor they usually use a generator they do not need a permit. But if they are cooking with charcoal they are still required to have an up to date and tag and seal fire extinguisher. All vendors that are using propane must be inspected, enclosed units in the State of New Jersey must be fire suppressed and all grill and fryers must be free of grease and they must purchase a bottle of leak tech from any plumbing supply company and the bottles must come down here when they are inspected and be on scene at all time during the event. Their hoses must be crack free and propane tanks must be no older than 10 years old.

Also, if you are using a tent bigger than a 10 x 10 there may be a separate permit required by the Camden County Parks Department and/or Camden County Fire Marshalls Office.

Each vendor must pay a \$54.00-dollar (confirm amount as fees increase each year) fee and the permit will only be good for that day only. Please verify the fee with the Fire Marshal's office; the price may have increased or decreased.
