**Tickets:**

Tickets may be purchased for other attendees and then transferred. Refunds will only be available in the event that the convention is canceled for unforeseeable or extreme circumstances.

**Guests:**

**The guests have been contacted and booked to the best of the organizers' abilities but there is still a chance of cancelation.**

If a guest cancels it will not be grounds for refund of specific tickets. In the event of a cancelation, adjustments will be made accordingly regarding photos and autographs purchased as far as transferring to a different guest.

**Code of Conduct:**

**The Restoration Retreat is intended to be an event that celebrates The Fortnight and the fans.** It is expected that the attendees and/or fans in attendance will treat each other with respect and kindness regardless of the real or perceived race, sex, class, sexual orientation, etc of any other guests, staff, or talent in attendance.

The following behavior is prohibited at The Restoration Retreat:

- Any sort of disruptive or dangerous behavior towards guests, attendees, volunteers, or staff.
  - o This includes behavior that causes any guest or attendee to be uncomfortable or has been addressed as being inappropriate.
- Sexual harassment or misconduct to include inappropriate touching.
- Any potentially dangerous behavior.
- Any behavior that is disruptive to the hotel attendees or in violation of the hotel rules.

**Any violations of these rules that are seen or reported will result in one or both of the following:**

- The reported offender will be warned regarding their behavior and told to stop whatever has resulted in the complaint.

- The reported offender will be instructed to leave the convention without a refund and will not be allowed to return.

**The violation does not have to be handled by a warning first and a first violation can be handled by revoking the offenders pass. Final say of which outcome will occur will be determined by the staff of the convention.**

Staff will be posting videos of the panels after the conclusion of the convention.

Photography and video will not be permitted in any of the autograph/photo rooms. If you are caught taking photos and videos you will be asked to leave. Videos or photography during the meet and greet portions will be at the discretion of the guest.

You will not be allowed to record videos for any commercial, blogging, or any other sort of promotional purposes unless you have been permitted to by the staff.

#### **Autographs and Photo Ops:**

Autographs will be available for purchase before and during the convention. Purchase at the convention will be dependent on tickets sold prior to so we strongly urge you to purchase prior to the convention. Any purchases at the convention will be cash only (US currency).

Please bring and display your ticket at the autograph table and it will be used for access. Attendees with tickets can have a complimentary photo signed by the guest **OR** one item of your choice. **Multiple items will require separate or additional ticket purchases.** All items used for autographs are subject to guest approval and guest reserve the right to refuse and/or not sign any item they deem inappropriate or offense.

Photo ops will be available for purchase before and during the convention. Purchase at the convention will be dependent on tickets sold prior to so we strongly urge you to purchase prior to the convention. Purchases during the convention will be dependent on space and time available Any purchases at the convention will be cash only (US currency). Please bring and present your ticket at the photo op table. Guests reserve the right to not pose or be photographed with anyone who makes them feel uncomfortable.

Due to time constraints please limit your conversation with the guests during your autograph and photo ops out of respect to the other attendees. Lines will be monitored and in the event you are holding up the line, staff will ask you to move along.
