## *What is a legals only ceremony*

*A Legals only ceremony is when you just want to sign the paperwork & be married! Super stress free & easy, with minimal words!*

*Perfect to ensure you are legally married in Australia before an overseas wedding date is taking place or if you are looking to keep the event private.*

*We complete the paperwork, say the 127 legal words only, then sign to seal the deal in the presence of 2 witnesses, which I can provide if required.*

*This ceremony does not include an asking, personal vows or ring exchange. (Can upgrade to Legals PLUS package)*

*The package is for a maximum of 4 people, which is the couple and 2 witnesses only plus myself, of course!*

*Why not upgrade to a **Legals PLUS** ceremony & make it a little more special with a few more guests.....this Includes any of the following Ring Exchange, Asking questions, Personal Vows, signing table & 2 chairs, up to 10 people attending & assistance with permit application if required.*

## *Process*

*Contact me to arrange our meeting time.*

*We can meet (in person or virtually), plan a date, answer your questions and complete required paperwork. The Notice of intention to marry, NOIM, requires one month before your ceremony, unless a shortening of time is granted.*

*With this ceremony you only need to say the legally required sentences then sign the paperwork in my presence and 2 witnesses. I can also provide the witnesses if you would like.*

*This ceremony will take 10mins on the day. Legals Plus 10-20mins*

*After the ceremony I lodge all paperwork on your behalf with the correct BDM.*

## *Package Inclusions*

*Included in your package:*

- A meeting in person or virtually to plan and complete all the legal paperwork, including the NOIM.*
- All paperwork completed and then submitted to Correct BDM on your behalf after the ceremony. Can also apply for the official marriage certificate for the relevant additional cost*

- ✪ Your ceremony being conducted at the agreed time and place, can be your house, my house or even a café! Approximately 10mins total saying the legal wording only.
- ✪ Providing of 2 witnesses over 18 years of age if required. (additional fee applies)
- ✪ Commemorative certificate to take away on the day.
- ✪ Travel within 30kms of Pacific Pines, Gold Coast

## Investment

*This totally intimate ceremony is available:*

- ✪ Monday to Friday for \$425
- ✪ Saturday, Sunday for \$525.... between 9am and 12noon

**Legals PLUS** Includes Ring Exchange, Asking, Personal Vows, signing table & 2 chairs, up to 10 guests & assistance with permit application if required.

Monday – Friday \$550

Saturday, Sunday \$650 between 9am and 12noon

- ✪ Providing of Witnesses \$50 per witness

**Celebrate with Lucy will keep the agreed date and time available for your ceremony in accordance with the following:**

- 1) A confirmation booking fee of **\$200.00** is payable. This fee also covers the lodgement of your Notice of Intended Marriage, if a wedding. This fee is not refundable.
- 2) The balance of your account is due and payable one month prior to your ceremony date.
- 3) In the event that the ceremony is delayed more than **30 minutes** beyond the agreed starting time, Lucy reserves the right to proceed to her next commitment.
- 4) In the event of cancellation of the ceremony, the non-refundable deposit will be forfeited and the balance of the fees will be considered, and will be at Lucy's discretion.
- 5) In the event of a change of date, a fee of \$50.00 may apply and is subject to Lucy's availability.
- 6) Additional Travel fees apply for over 30km travel from Pacific Pines, charged at \$18.75 per 15km block.
