☐ 'AS IS' CONDITION: The purchaser acknowledges that the animal is sold 'as is'. The purchaser accepts the kitten in its existing condition and that the purchaser has either inspected the animal or was given the opportunity to inspect the animal. The purchaser will have 5 days to confirm the health of the kitten with a licensed veterinarian. If any serious health issues of the kitten are identified, after providing proof from the veterinarian, the purchaser can return the animal and get a full refund or replacement of a kitten of equivalent value. The replacement kitten will be taken from a future litter and will be of the same value as the original kitten. The seller will not be held responsible for any veterinary bills incurred by the purchaser for any reason. The purchaser will have to return the kitten within 10 days of purchase.

☐ The deposit amount of: \$1,000.00 has been applied to the purchase price with a balance due of \$2,700.00 which shall be paid in cash upon release of the kitten to purchaser.

☐ If for any reason I become unable to care for the said kitten/cat I must notify the breeder. If suitable rehoming is not an option, I agree to return the kitten/cat to the seller at purchaser's expense. Under no circumstances will this kitten ever be abandoned, given to any pet shop, humane society, pound, shelter, research facility, or euthanized for behavioral problems.

☐ I understand that once I take ownership of the kitten/cat I am responsible for the cat/kitten for the rest of its life. I understand I am responsible for all aspects of its wellbeing, including maintaining a proper diet, providing a safe home, and all veterinary related costs. I agree to quarantine the kitten for at least 10 days from other animals and am liable for all illnesses that may result if I fail to do so. I agree that the kitten/cat is indoor only.

☐ I agree that the kitten/cat will not be declawed and is purchased solely as a pet, not be used as bait, fodder, or used for work or breeding purposes. I agree to send photos of the kitten at 1 year of age.

☐ Buyer acknowledges that a) a material condition of this sale and transfer of this pet is that this pet is a non-breeding animal, and b) that the pet is being sold to Buyer in reliance on Buyer's compliance with the obligation to sterilize the pet before the deadline 'xxx' set forth in their SpaySecure agreement. In so acknowledging, Buyer agrees to sign and comply with all terms of the SpaySecure sterilization agreement, to not breed the pet, and to take the pet to a licensed Veterinarian and have it surgically sterilized before the specific deadline set forth in their SpaySecure sterilization agreement.

☐ Seller guarantees that the kitten is free of hereditary malformation to the best of Seller's knowledge at the time of sale. In the event that a hereditary malformation (genetic defect) is found within one year of purchase that would cause a major financial burden or terminal illness, seller agrees to replace kitten of equal value from a future litter. No medical or shipping costs will be refunded.

☐ Kitten has been examined by a veterinarian and has had 1st round of shots and deworming by 13 weeks of age. See health record for details. Purchaser assumes responsibility to vaccinate kitten thereafter as recommended by their veterinarian. The purchaser assumes all risks associated with overvaccination.
