### **### TERMS AND CONDITIONS**

**1. \*\*Services Provided:\*\***

The DJ agrees to provide music and entertainment services as per the Client's request, including setup and teardown of equipment.

**2. \*\*Payment Terms:\*\***

4. **\*\*Event Changes:\*\***

Any changes to the event details (e.g., time, location) must be communicated to the DJ at least 7 days in advance. Changes are subject to DJ's availability and may incur additional fees.

5. **\*\*Extra Hours\*\***

If the Client requests the DJ to work beyond the contractual time, the DJ will charge \$100 per hour or part thereof.

- The Client is responsible for any damage to the DJ's equipment caused by guests or other individuals at the event.
