The organization is a 501(c)(3) nonprofit dedicated to supporting lupus survivors with the mission to provide education, advocacy, and compassionate support for individuals battling lupus, while uplifting survivors and promoting awareness of the chronic autoimmune disease.

Lupus, also known as systemic lupus erythematosus (SLE), is a chronic autoimmune disease that can affect various organs and systems in the body. Symptoms can vary widely, but often include joint pain, stiffness and swelling, fatigue, rashes, light sensitivity, and kidney, heart, lung and neurological issues.

'The evening will highlight stories of strength, hope and resilience within the Lupus community," said Fifty Shades founder and lupus survivor, Maria Harris.





# Public Service Commission race was about pocketbooks, not politics

am getting mail giving me credit for the defeat of the two incumbent Republican members of the Georgia Pub-

lic Service Commission this past week. I am getting mail blaming me for the defeat of the two incumbent members of the Georgia Public Service Commission this past week. To quote Mark Twain when he read a report he had died: "The report of my death was an exaggeration." So was my influence on the outcome of the PSC elections.



If I had that kind of influence, nobody would dare think of drilling in our Okefenokee National Wildlife Refuge for titanium dioxide in order that the world never run out of toothpaste whitener. I have expressed righteous indignation on the subject numerous times yet my sources tell me the issue is still very much a possibility, thanks to an unholy alliance of powerful timber barons, disingenuous politicians and sneaky chemical companies. More on that subject later. Today, we are talking about why the two incumbent commissioners, Tim Echols and Fitz Johnson, were given the heave-ho by the

According to the Atlanta Journal-Constitution, nearly 1.5 million Georgians voted in the PSC race. Democrats Alicia Johnson and Peter Hubbard won their seats on the commission by roughly 25 points. Not even close.

Looking back, the defeat of Echols and Johnson was no surprise to me. I got the feeling early on that there was a real

possibility the two incumbents were in trouble when I kept reading and hearing that the election was all about Republicans versus Democrats. If Democrats won, Georgia would become "another California." Windmills and solar panels and transgender operations for prisoners. Except to the voters it wasn't about party loyalty or California. It was about our utility bills.

I think the reason the political consultants made the PSC races about party loyalty was that selling the performance of Echols and Johnson as effective utility regulators was not an option. No one wanted to talk about six rate increases in the last three years (Note: Commissioner Echols told me that six increases was not correct. There were only three. One increase was phased in over three years. I will leave it to you to decide if you want to count that as one hit to your pocketbook,

How do you tiptoe past voters the fact that the average Georgia Power residential customer's bill has increased about \$43 per month or over \$500 annually? You raise the specter of Georgia becoming the land of Fruits and Nuts and for good measure you throw in transgender operations for prisoners as an additional idiotic reason.

The Georgia Public Service Commission is seen by many as being too cozy with Georgia Power. To voters, perception became reality. As I wrote earlier, the PSC has allowed Georgia Power to charge ratepayers for \$7.5 billion of the \$10 billion in costs overruns at the Vogtle nuclear power plant, instead of making Southern

Company shareholders pay. Georgia Power is a Southern Company subsidiary. As information, Southern Company reported 2024 earnings of \$4.4 billion, a \$400 million or 10 percent increase from 2023. Those are bad optics, folks. Why should we ratepayers be on the hook for Georgia Power's cost overruns? It is not our fault they blew their budget.

Earlier this year, the commission voted unanimously to freeze base power rates for the next three years, although your power bill could still be "adjusted" next year for fuel prices and hurricane cleanup costs, which could mean a further rate increase on your monthly bill.

If any of the geniuses who provided political advice to the two incumbents are reading this, my reader mail might be instructive. A lot of readers consider themselves Republicans, but not automatons. They told me they didn't vote for the incumbents for many of the reasons listed above. Pocketbooks above party.

To the Democrats high-fiving and thinking this is the first sign of a political left turn in our state, don't get your hopes up. This was a pocketbook issue, not a political statement. Like your Republican colleagues you are being held captive by the extremists in your party.

To the Republicans braying about Georgia becoming California, may I remind you that you still have a 3-2 majority on the commission. I would suggest you tell those three members that going forward they pay more attention to us and less to Georgia Power's wish list and there is a good chance we won't have to have this particular conversation again.

**¬**oday was a day of reflection for me. I was looking back on some 40 or more graduations

I presided over during my time as president of Point University. As I reflect on the thousands of students who graduated during my tenure, I am aware that those of us who work in higher education can fall into the trap of going through the motions of the ceremony, but it is a really

big deal and a very big day for the graduate and their families. The roll call of graduates includes many first generation college graduates. What a proud moment for parents, grandparents, and other family members as they watch their whole family tree transform with this moment of accomplishment. There are always some who barely made it and others who have

some of the finest minds the professors have ever taught. And every one of those graduates has a story.

Many times over the years I felt tears well up listening to the brokenness and life circumstances of many of our students, and often I was overwhelmed with joy and gratitude to have played some small role in their journey. But as I reflect on all these commencements this morning, I thought about what we provided to the graduates. Of course, the obvious — an education that I believe better prepared them for a life and a path to a job and career. And when they graduated, it placed them in the top third of the U.S. population who have earned a college degree. But the thing that struck me this morning was what we provided for them that is better than a college degree.

Everyone who walked across the stage at each commencement had been exposed to the life changing power of the gospel. God allowed us to plant

seeds of faith that for some have not fully bloomed and for others grew strong right in front of our eyes. Let me remind you what Paul says about this transformation:

"He has delivered us from the domain of darkness and transferred us to the Kingdom of his beloved son."

Long before each graduation, we received an application, reviewed it, accepted a student, provided an education, and at graduation, awarded a degree. And in the process, we likely transferred some credits from previous work and provided a way for a student to earn enough credits to graduate. But we also introduced these students to a Savior who made a bigger transfer of credit. He canceled their debt of sin and transferred them from darkness to a Kingdom of light.

I pray I never forget what happens at a Christ-centered university. What we do matters in this world and for eternity.

A new era of

**GHSA** officially announces new classifications and regions for 2026-2028

The Georgia High School Association (GHSA) has heard all appeals for the new classifications set for 2026-2028. The classifications and regions are now set, and all three local public high schools (Callaway, LaGrange and Troup) will have teams old and new in their new regions.

Callaway will be moving up a classification from 2A to 3A and will be in a region centered around Macon. Alongside the Cavaliers in Region 2-3A are Central-Macon, Jackson, Lamar County, Northeast, Pike County, Rutland and South-

Jackson, Pike County and Rutland are currently in the same region as the Cavaliers. Callaway was most recently in a region with Lamar County from 2016 to 2010. The Cavaliers have never been in a region with Central-Macon, Northeast and Southwest, and have never met either of the three teams on the gridiron in any capacity.

For the first time since 2015, LaGrange and Troup will play different classifications and subsequently different regions. Just like in 2015, La-Grange will play in the AAAAA classification while the Tigers will play in AAAA.

The Grangers will be joined in Region 3-5A by Banneker, Central-Carrollton, Griffin, Harris County, Lithia Springs, Starr's Mill and Whitewater. The Grangers and Whitewater currently play in the same region. LaGrange was previously in a region with Starr's Mill from 2022-2024 and Central-Carrollton from 2016-

It has been quite some time since LaGrange and Harris County shared a region, when the two played in the same region from 2004 to 2008. It has been even longer for the Grangers and Griffin, who last shared a region together from 1996 to 2000.

LaGrange has never been in the same region as Banneker and Lithia Springs.

Troup will be entering region 2-4A alongside current region opponents Mary Persons, Spalding and Upson-Lee, as well as newcomers Baldwin, Howard, Peach County and Westside-Macon.

This will be the first time that Troup shares a region with Baldwin, Howard and Westside. The Tigers previously played in the same region as Peach County from 1998-

The new regions will officially go into effect at the conclusion of the 2025-26 school year. The GHSA reevaluates classifications and regions every two years.

Another big change from this season to next will be the conclusion of the PPR rankings, which means that only region champions will be given automatic playoff bids, while other teams will be ranked according to the new power rankings that factor in strength of opponents, strength of schedule, and a myriad of other factors.

# PARTY LIKE IT'S 2008

# LaGrange College football wins first conference title in 17 years

It's LaGrange College's time. The Panthers hosted Belhaven on Saturday for the de facto USA South Conference Championship and secured their first conference title since 2008 with a 38-6 win.

"I think we played as close to a complete game as we have played all year," LaGrange College head coach Wes Dodson said. "This is huge, not just for the football program, but for the college in general. We are in Georgia, where football is king, and the football here hasn't been very good for a while, and now we have won a conference championship."

The Panthers put their stamp on the game early, taking a 14-0 lead in the first quarter.

The teams traded punts to start the game before Legend Doggett intercepted his first pass of the game and returned it to the Belhaven 33-yard line. The defensive back celebrated accordingly, joining the cheerleaders and sending the crowd into a riot.

Two plays later, Tacaris Bozeman flipped into the end zone on a 33-yard run to put the Panthers up 7-0.

The Blazers took a big risk on the ensuing drive, attempting a fourth-and-one on their own 36-yard line and failing to convert. Bozeman would punctuate a 7-play drive with his second touchdown of the game, this one from five yards out. It was a big game from the junior, who finished with 11 carries for 116 yards and two touchdowns. The star running back was also the team's leading receiver with two catches for 70 yards.

"All of our running backs have done a great job these last four to five weeks, and it's like they take turns on who is going to have a big game, and this week it was Bozeman," Dodson said.

The entire LaGrange College rushing attack was lethal all game, compiling 276 rushing yards to Belhaven's 12 total rushing yards.

Equally as important was the play of the Panther defense, which forced five turnovers and had three sacks on the afternoon. LaGrange College allowed just 216 total yards in the game.

Doggett was the star of the show and intercepted his second pass of the game when the Blazers had the ball in the LaGrange College red zone midway through the second quarter.

"He is the type of corner that can take

away an entire half of the field, and you saw that today," Dodson said. "He's such a good football player and makes plays for us every

Special teams were a bit of an issue, with a missed field goal and a blocked field goal ensuring that the Panthers could not extend

their lead past 14-0 going into halftime. LaGrange College came out of the halftime break throwing haymakers. On the second play of the second half, quarterback Kirk Scott went 69 yards to the house to deliver a dagger through the Blazers' hearts.

"He's one of the best athletes on the team, and he just happens to play quarterback," Dodson said. "It was a big momentum play coming out of the half for us."

Scott turned eight carries into 91 yards and a touchdown.

The two-quarterback system for the Panthers was on full display. Pocket passer Henry Brodnax delivered his signature moment of the game with 7:09 left in the third quarter when he threw a beautiful ball to Aaron Bryant on a 9-yard touchdown to put LaGrange College up 28-0.

A 31-yard field goal from Landon Eaker late in the third quarter made it 31 unanswered points to start the game.

The Belhaven offense finally answered the bell, scoring a touchdown with 1:05 left in the third quarter, but the deficit proved to be too large for it to make a difference.

# **STATS TO KNOW:**

In addition to the two interceptions by Doggett, Brandon Brooks, Keyon Stoutemire and Ched Smith all had one apiece. Smith also led the team in tackles with four.

Dezmond Jones, Deon King Jr. and Zymarion Hudson all had a sack each for La-Grange College.

Michael Hayes turned 11 carries into 25 yards and scored the final touchdown of the game, a 1-yard rush early in the fourth

# **WHAT'S NEXT:**

LaGrange College has won seven games in a row, improving to 8-1 overall and 6-0 in conference play.

The Panthers will wrap the regular season next Saturday on the road to Southern Virginia University.

LaGrange College has secured the conference championship and a berth in the NCAA Division III playoffs as well as its second straight winning season, the first time the program has ever accomplished

"I wouldn't say I'm satisfied, but it's refreshing and I'm excited that we were able to accomplish these things this year," Dodson said. "We still have another game week, so hopefully we can work towards hosting a playoff game, or even having a first-round
