- 1. Hire costs of Courts 2021: \$50 per hour per court. A daily rate is available where full days are requested. Tables: \$5.00 each. Chairs \$1.00 each. If A/C is required, the cost per hour per court will be \$55.
- 2. The hirer must ensure all activity and events are fully managed and controlled.
- 3. ISS Canteen. The operation of the Canteen will be managed and operated by the Illawarra Sports Stadium from 1 April 2020. Please contact **Alex (Operations Manager) on 0447 332 525** at least 7 days before the event with level of catering required and expected number attending to ensure adequate catering.
- 4. The hirer must ensure all spectators and competitors act in a responsible manner while in the stadium and its surrounds.
- 5. The hirer must contact the Operations Manager on 0447 332 525 or Ian (Managing Director) on 0411 451 863 24 hours prior to the event to confirm arrangements.
- 6. The hirer is responsible for adherence to all requirements of the Halls and Public Theatres Act.
- 7. Access to the stadium will be as per arrangements with the operations manager.
- 8. Where change rooms, shower and internal toilets are in used these must be inspected regularly to monitor use and ensure that such facilities are in acceptable condition for use.
- 9. All loose rubbish and water spillage must be removed from all areas immediately.
- 10. Where keys are issued that must be returned at the conclusion of the event.
- 11. The agreed bond and/or deposit must be paid 14 days prior to the event and the agreed hiring fee should be paid as per arrangements or at the conclusion of the event.
- 12. Please contact the Operations Manager on 0447 332 525 in case of emergency or any other problems.
- 13. The hirer is responsible for any damage to facility. Where lights and light fittings are damaged a fee of \$250 (two hundred and fifty dollars) is payable for each incident immediately.
- 14. Should the Illawarra Sports Stadium receive a request to host a "special event", the Board reserves the right to advise the hirer of the unavailability of the facility.

## Additional Conditions of Entry due to COVID-19
