Mill Boutique Consignment Agreement

This agreement is being made between _____ [consignor]

1. Consignor has turned over the attached list of goods, which shall remain property of the Consignor until such time as they are sold. Any boxes and displays must be clearly labeled with name of Consignor.
2. Customer operates a retail store or other sales outlet and agrees to make his/her best effort to sell Consignor's goods.
3. Customer agrees to return to Consignor, upon demand, any unsold merchandise. The goods must be returned in the same or similar condition, unless this is impossible due to shopper damage or theft.
4. Customer, at his/her own discretion, may opt to return unsold goods to Consignor at any time.
5. Customer agrees to sell the goods at the listed price points, unless Consignor agrees to mark down as described on attached price lists.
6. Customer agrees that all proceeds due, **minus 20% commission**, will be available to Consignor on a monthly basis, if warranted by volume of sales.
7. The CMHF, a non-profit organization, cannot be held responsible for goods that are lost or damaged while under the control of the Customer.
8. Consignor agrees to pay a **\$20 Administration Fee** for the season which includes the summer and Christmas Market consignment boutique.
9. This agreement can be terminated by either the Consignor or Customer at any time.
