

# DOG BOARDING

## *Agreement*

This contract (the "Agreement") is entered into between Border Farm Luxury Boarding Kennels (hereinafter referred to as "Border Farm Luxury Boarding Kennels," "We," or "Our") and ..... hereinafter referred to as the "Owner," "You," or "Your")

### **DOG BOARDING SERVICES**

Border Farm Luxury Boarding Kennels will provide a safe, clean, and caring environment for the dog(s) throughout the duration of the services. This includes ensuring that adequate shelter, comfortable bedding, sufficient food, and clean water are readily available to promote the dog(s)' well-being. Border Farm Luxury Boarding Kennels acknowledges and agrees to adhere to the feeding schedule and dietary requirements specified by the Owner. Appropriate provisions will be made to ensure that the dog(s) receive the necessary physical activity, playtime, socialization, and companionship. The dog(s)' medications will be administered according to the Owner's explicit instructions.

### **DOG OWNER RESPONSIBILITIES**

The Owner should ensure that their dog(s) have the appropriate tags and collars for identification. The Owner should ensure the health of their dog(s) before check-in. The dog(s) should be free from contagious diseases for at least 14 days prior to their stay, and the dog(s)' vaccinations and flea/tick prevention should be current. The Owner will provide clear and detailed instructions for any required medications or special dietary needs, and any medications should be properly labeled. Any known behavioural issues or aggression must be disclosed to Border Farm Luxury Boarding Kennels. This information is essential for the safety of both the dog and boarding staff.

**PAYMENT AND FEES**

The Owner agrees to pay Border Farm Luxury Boarding Kennels the boarding fee as outlined in the prices below:

SERVICES DESCRIPTION	COST

A 10% deposit should be paid prior to the check-in date, and the remaining fees are due upon check-in. Additional services, such as grooming and transportation, will be subject to additional fees. The Owner will be responsible for the payment of these additional service fees.

The Owner acknowledges that the late pick-up of their dog(s) beyond the agreed-upon check-out date and time will result in additional fees. If the Owner collects their dog(s) before the agreed end date, they will still be charged for the original booking.

**CANCELLATION AND TERMINATION**

To cancel or alter the services, the Owner is required to provide written notice at least 24 hours prior to the check-in date. If a cancellation is made after this period, the deposit will not be refunded and 50% of the booking payment will be required. Border Farm Luxury Boarding Kennels reserves the right to cancel or terminate services at any time due to reasons that may include, but are not limited to, aggressive dog behaviour or false information provided. If Border Farm Luxury Boarding Kennels cancel the Services, the Owner will be notified promptly. In case of termination, the Owner may not be entitled to a refund of any balance due.

## EMERGENCIES

In the event of a pet medical emergency, every reasonable effort will be made to contact the Owner or emergency contact immediately. If this cannot be done in time, Border Farm Luxury Boarding Kennels is authorised to seek the veterinary care necessary for the dog's health and safety. The Owner is responsible for all associated veterinary expenses.

## LIABILITY

Whilst every care will be given to your dog(s), Border Farm Luxury Boarding Kennels will not be held responsible for any illness, injury, loss or damage to the dog(s) or their belongings, however caused, during their stay. Boarding is entirely at the Owner's risk.

## ENTIRE AGREEMENT

This contract constitutes the entire agreement between the Owner and Border Farm Luxury Boarding Kennels regarding the services and supersedes all prior discussions, understandings, representations, and agreements, both written and verbal.

## FORCE MAJEURE

Neither party shall be held accountable for unforeseeable circumstances or events beyond their control, including acts of nature, government actions, war, epidemics, or other events hindering the contract's performance. The affected party must promptly notify the other party and make reasonable efforts to mitigate the event's effects.

## SEVERABILITY

If any provision of this Agreement is found to be invalid, illegal, or unenforceable under applicable law, the invalidity, illegality, or unenforceability of such provision shall not affect the validity or enforceability of the remaining provisions of this Agreement.

*No modification, amendment, or alteration of this Agreement shall be binding unless it is made in writing and duly executed by both parties. By signing below, both parties acknowledge and agree to the terms and conditions stated in this Agreement.*
