STOP WRONGFUL REZONING AND ENCOURAGE SMART GROWTH WITH COMMUNITY-BASED PLANNING

Our community is unhealthy and you see it every day in many ways. The roads are dangerously congested. There are problems with water and sewer resources. We pay one of the highest school levies in the state. Our problem is rapid-haphazard growth. I believe that the City of Ammon leadership goals are too narrow and because of this our community is not being protected. Please don't get me wrong, I am not anti-growth. I am for PLANNED-SMART growth.

Idaho has very few laws on city growth. They suggest studies for items like traffic, water, sewer, crime and pollution. Advise to cooperate with the school system and represent their needs. They require city ordinances, and a master (comprehensive) plan. However, those items are easy ignored, too vague to help, and/or changed whenever leadership's desires. I have witnessed it.

<sup>&</sup>lt;sup>1</sup> In May of 2020, 50 citizens tried to have a rezoning denied; we gave example after example of how the rezoning was violating the city ordinances. At first they approved the rezoning even with a lawyer involved. Since I was directly impacted, I asked for a reversal based on city employee's mistakes. The city reversed its decision and denied the rezoning. The city then voted in a new ordinance that changed the requirements. The rezoning was then approved again - about three months later.
