Local Land Use Planning Act is powerful. It allows the leadership to rezone, annex, and basically shape the city's present and future development and landscape. The act requires that studies are to be completed to understand the status of the city. A comprehensive plan with ordinances are to be used to create goals and a future design for the land use.
