

MEETING MINUTES OF THE VERNON FIRE DISTRICT BOARD

REGULAR BOARD MEETING OF VERNON FIRE DISTRICT, 25 ACR 3142, VERNON, AZ 85940. PHONE: (928) 537-4895.

1. **CALL TO ORDER REGULAR BOARD MEETING**, meeting was called to order at 5:30 pm.
2. **ROLL CALL OF BOARD MEMBERS**, present were Gregg McClendon, Tony Anderson, John Vehar, Grey Murphy and Randy Mifflin via phone.
3. **PLEDGE OF ALLIEGENCE AND PRAYER**, The Pledge of Allegiance was recited, and Randy Mifflin prayed for the meeting.
4. **RECOGNITION OF GUESTS**, Wendy Sharp, Chief John Connolly and BC Vickers
5. **CALL TO THE PUBLIC**, John Vehar gave the call to the public; no public present for meeting
6. **REPORTS & CORRESPONDENCE**
 - A. Chair Summary – Board Chair John Vehar had nothing to report
 - B. Financial Report and Discussion – A motion to accept Resolution 2025-2026 was made by Tony Anderson, seconded by Randy Mifflin. Jacob With JVG gave the monthly financial report for October 2025, key points are the following, Revenue for the month of October is \$189,055, which is under budget by \$3,817. Tax revenue for October is \$167,850, which is under budget by \$21,414. Non-Tax revenue for October is \$21,204, which is over budget by \$17,596. Wildland revenue for October is \$8,118. Expenses for October are \$145,714, which is over budget by \$28,388. Personnel expenses are over budget \$22,463, driven by overtime and workers compensation. Managerial expenses are over budget \$5,023, driven by timing of accounting/audit invoices. Year to date total revenue is \$445,294, which is over budget by \$90,921. Year to date expense is \$563,817, which is over budget by \$95,566. Cash is \$646,956 as of October 31, 2025
 - C. Chief's Report and discussion – Chief John Connolly reported a total of 61 calls, which were mostly EMS. Training hours per shift were: A shift 82 hours, B shift 174 hours & C shift 127 hours of total training. No Wildland assignments to report. Miscellaneous items: Community meeting was scheduled for November 10th at 6pm in the Vernon Library for rezoning vacant Vernon Fire District land to commercial. Wendy Sharp to be signed up for in-house fingerprint and drug screen training set for beginning of next year. Triple Oak Wind project follow-up meeting.

 - H. **Discussion and possible action: Vehicles**, BC Vickers updates: E252 back from Shawn's Diesel, E251 back in service From Fire Truck Solutions (still finding small issues), Brush truck 251 has no issues, Tender 251 needs rear pump replaced, Tender 252 also needs rear pump replaced, Tender 253 still in valley for recalls & needs to be finished fitting for next wildland season, Brush 252 has plow on it and is ready for winter, Attack 251 has wiring issues, UTV251 winter tracks were received and placed at Station still waiting on rest of parts to replace sway bar, Support 254 needs multiple repairs.
