- **C.** Financial Report: Ben Archer from the James Vincent Group presented the report for September 2022. We started the month with \$61,644.31 and ended with \$39,350.99 in the county account. Special revenue account \$175,268.24. Payroll account \$32,449.24. We spent \$143,814.00 in September.

- B. Finalizing the purchase of the 4 acres from the Penelope Leslie estate thru Resolution 2022-04. John Vehar read the resolution, Paul Kovacic motion, Grey Murphy 2nd. Roll call vote. Vote: Yes Unanimous.

- D. Seeking for a CON has been put on hold to see if House Bill 2609 will pass that will assist the Fire District to acquire a CON easier. The writing of this bill has been delayed until 2024.
- E. Ben Archer from the JVG reassured the Board even though the passing of Barbra Barclay CFO the books look in good shape. It may take them working with Admin. for a month or two to get the books set up the way JVG would like them.
- **F.** It was discussed by Admin that annexation thru going door to door has stopped but they continue to work on annexation thru the Admin. Office.
- G. EVIT has recently gone thru management changes and unless they can prove to Chief Niehuis that this new program will work he will not be supporting it. In the spring we are going to mentor an 18 yr. student from the Northern Arizona Academy program who has an interest in becoming a Firefighter. This program covers all the student's expenses and their Workers Compensation.
- H. H & E revised invoice was provided to the board reflecting a reduced price by \$3,133.52 from the original invoice. Chief Niehuis commented that he thought this was a fair price and was satisfied with the work. The consensus of the board was to pay the revised invoice of \$17,729.73 to H & E.
