5. REPORTS & CORRESPONDENCE

- **A.** Financial Report and discussion: Gabe from JV Group presented the October report. We started the month with 68,157.03 and ended with 208,280.41 in the county account. Special Revenue account ended with 92,835.36. Payroll account 23,114.29. We spent 132,098.00.
- **B.** Chair Summary- John Vehar stated that since the open seats are not filled that the board may want to keep the current board in place. But if a board member wanted to be considered for the open seat they would not want to accept the board offer of extending their current term to be eligible to interview for one of the open seats. Adrian Aldredge agreed that he would be willing to continue until his seat is filled. Vote: Yes Unanimous. It was discussed they would follow the same procedure as last time. 1. At the December board meeting they will interview in executive session and do a blind vote in open session.
