Hiring Seasonal Emergency Medical Paramedic, Fireline (EMPF) for a Fireline Medical Team

These positions are to fill an opening on an apparatus when a Fireline Medical Team are resourced out and be paid by VFD. Wage for Fireline Paramedic is \$32.00 to \$35.00 per hour depending on experience.

This position will get Overtime after the first 40 hrs per week when on assignment.

Minimum requirements for this position are:

• Current Paramedic license. (must have Arizona state and National Registry Card.)

- Introduction to Wildland Fire (S-190)
- Annual Fireline Safety Refresher (RT-130)
- Human Factors in the Wildland Fire Service (L-180)
- Or a valid "Red Card" issued by your home agency with current RT-130 Refresher Cert.
- ALS or BLS CPR, and blood borne pathogen.
- UTV operator safety training and maintenance training.
- An arduous physical fitness level has been established for this position.
- Must have a valid AZ license. Be able to pass a drug test, and a background check.
- Ability to commit to 18-21 days with little to no notice.
- Possess all necessary personal items for a "3-week bag", etc. for extended assignment.
- You must be able to follow directions and be physically fit to perform the required duties.
