All items are set for possible action.

Pursuant to ARS § 38-431.01(H) the Fire Board is not permitted to discuss or take legal action on matters raised in the call to the public that are not specifically identified on the agenda. However, individual board members may respond to criticism, ask staff to review the matter, or ask that the matter be placed on a future agenda.
