Recap since July-we need to post getting bids for the BumpOut for our 100 ft Ladder Truck, (we have to have the 100 ft ladder truck no shorter because of our hotels on the west end of town, this helps everyone in town to have a lower insurance rating) Need to fix the Timberwolf air leak, oil leak and transmission leak. Checked with the Maintenance guy at West Metro to see what his rate is to help repair the truck. Need to get it fixed it was bought brand new and just got it paid off. The cost for the BumpOut will cost \$80,000.

Want to change our board meeting nights to the second Wednesday of the month permanently so that the members of the fire department that are also members of the ambulance department can attend both meetings since the ambulance department also meets on the third Wednesday of every month. This will allow them to attend both without conflict. Our January meeting will be a special meeting date of January 10, 2024, and we will make the change with a resolution for the new year to change our meeting date.

new patch on it to Will. Thanked Will for advocating for LAFPD.
