Approval of Minutes:

Mayor Maglio requested a Motion to approve the February 25, 2025 Mayor and Committee minutes. Motion by Committeeman Heigis. Second by Deputy Mayor Bechtold. All in Favor.

Discussion:

The Sandyston Fire Department agreement was discussed and approved.

The completed SCMUA Resolution was acknowledged.

Approval and insurance has been obtained for Walpack to hold Primary voting at the Sandyston Municipal Building. Acknowledged.

Deputy Mayor Bechtold shared that he had attended the Mayor/NJSP/Sheriff's Department meeting held in Green Township. He shared that the National Park Service has jurisdiction in Walpack, followed by the New Jersey State Police, unless the call is concerning private property. NJ State Police have jurisdiction over private property calls in Walpack Township, National Park Service has jurisdiction over calls other than those responding to calls at private properties. NJSP responded to two calls last year. Other townships recorded hundreds of NJSP calls.

Mayor Maglio opened the floor to the Public for comment regarding the 2nd reading of Ordinance #01-25. Hearing no Public comment, Mayor Maglio closed the floor to the Public for comment regarding Ordinance #01-25.

Ordinances:

Ordinance #01-25. Second reading. Calendar year 2025. An Ordinance to exceed the municipal budget appropriation limits and to establish a cap bank (NJSA 40A:4:45.14) Mayor Maglio requested to Motion to Approve Ordinance #01-25 on Second reading. Motion by Committeeman Heigis. Second by Deputy Mayor Bechtold. All in Favor.

Ordinance #02-25. First reading. An Ordinance to authorize the execution of an interlocal agreement establishing a joint court to be known as "The Frankford Joint Municipal Court." Mayor Maglio requested a Motion to approve Ordinance #01-25. Motion by Committeeman James Heigis. Second by Deputy Mayor Bechtold. All in Favor.

Resolution R-21-25. A Resolution approving bills and vouchers for payment. Bills list attached. Mayor Maglio requested a Motion to approve R-21-25. Motion by Committeeman Heigis. Second by Deputy Mayor Bechtold. All in Favor.

Resolution R-22-25. Resolution for Budget Self Examination. Mayor Maglio requested a Motion to approve R-22-25. Motion by Committeeman Heigis. Second by Deputy Mayor Bechtold. All in Favor.

Resolution R-23-25. Resolution to approve and introduce the 2025 Municipal Budget. Mayor Maglio requested a Motion to approve R-23-25. Motion by Committeeman Heigis. Second by Deputy Mayor Bechtold. All in Favor.

MCFO explained that there were not many changes from last year in the Municipal Budget. She explained that Surplus and State Aid are our means. Over \$10,000 in taxes were uncollected last year. The Mayor and Committee voiced that action needs to be taken regarding the uncollected tax. Walpack continues to have no municipal tax.

Mayor Maglio opened the meeting for Public Comment. Hearing no Public Comment, Mayor Maglio closed the floor for Public Comment.

Mayor Maglio asked the members present if they had any additional concerns for discussion. Deputy Mayor Bechtold advised that Viking Pest Control charges Walpack \$1000 per year. Deputy Mayor Bechtold is currently maintaining the traps himself As a result, the Deputy Mayor cancelled the next Viking Pest Control service at the Municipal Building/Schoolhouse, and he suggested that we cancel the contract with Viking Pest Control.

Mayor Maglio requested a Motion to cancel the Viking Pest Control contract. Motion by Committeeman Heigis. Second by Deputy Mayor Bechtold. All in Favor.

CMFO will cancel the Viking Pest Control contract.

Deputy Mayor Bechtold advises that the tarp that was over the schoolhouse is completely off. Deputy Mayor Bechtold states that Chris Happe had ordered a new tarp in February, per a conversation they had had in the same month. Deputy Mayor Bechtold will inquire about the timeline to complete the re-tarping. He will also arrange for photos to be taken of the roof prior to the roof being re-tarped.

Regarding the Flatbrook Fire House, Deputy Mayor Bechtold will meet with Mark Miller who has expressed an interest in repairing that building and keeping the tractor in it that is used to maintain the cemetery.

Hearing no further discussion, Mayor Maglio requested a Motion to adjourn. Motion by Committeeman Heigis. Second by Deputy Mayor Bechtold. All in Favor.

ORDINANCE #02-25

AN ORDINANCE TO AUTHORIZE THE EXECUTION OF AN INTER-LOCAL AGREEMENT ESTABLISHING A JOINT COURT TO BE KNOWN AS "THE FRANKFORD JOINT MUNICIPAL COURT"

BE IT ORDAINED by the Township Committee of the Township of Walpack, County of Sussex, and State of New Jersey as follows:

Section 1.

- 1. The Mayor and Township Clerk are hereby authorized to execute an Agreement establishing a Joint Municipal Court known as "The Frankford Joint Municipal Court" pursuant to the authority granted to the municipality by N.J.S.A. 2B:12-1 et seq. The Agreement is attached hereto as **Exhibit A**, and its terms and conditions are incorporated herein by reference, as though set forth at length.
- 2. This Ordinance will be effective upon the adoption of reciprocal Ordinances by the governing bodies of all participating municipalities, the Township of Frankford, the Township of Lafayette, the Township of Sandyston, the Township of Montague, the Township of Walpack and the Township of Hampton.
- 3. The Joint Municipal Court heretofore existing and known as The Municipal Court of Frankford, Lafayette, Sandyston and Montague/Walpack shall be abolished and its function, powers and duties, records, property and pending cases shall be transferred to the new Joint Municipal Court established herein on January 1, 2026, subject to approval by the Administrative Office of the Courts and the Presiding Judge.
- **Section 2. Severability**. If any section, paragraph, subparagraph, sentence, clause, or phrase of this Ordinance shall be held to be invalid by any court, such decision shall not invalidate any remaining portion of this Ordinance.
- **Section 3.** Codification. This Ordinance shall not be codified in the Township Code, but may be reflected as a "New Law' in the Township's electronic code.
- **Section 4. Effective Date**. This Ordinance shall take effect upon final passage and publication in the manner provided by law.
- **Section 5.** Repealer. All Ordinances or parts of Ordinances inconsistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency.


